

## End-of-Sale and End-of-Life Announcement for the Cisco CRS-1 Series 42-Port Gigabit Ethernet Interface Module

Cisco announces the end-of-sale and end-of-life dates for the Cisco CRS-1 Series 42-Port Gigabit Ethernet Interface Module. The last day to order the affected product(s) is May 13, 2015. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.
