The last day to order the affected product(s) is November 18, 2025. End-of-Life Announcement Date	The date the document that announces the end of sale and end of life of a product is distributed to the general public.	May 20, 2025
End-of-Sale Date: App SW	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	November 18, 2025
Last Ship Date: App SW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	February 16, 2026
End of SW Maintenance Releases Date: App SW	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software.	May 18, 2026
