Overview

Cisco announces the end-of-sale and end-of-life dates for the Cisco Secure Network Analytics SAL-OP License (Secure Analytics Logging - On-Prem License). The last day to order the affected product(s) is September 25, 2025. The last day to renew or add to an existing subscription is December 25, 2025. Customers with active service contracts and subscriptions (as applicable) will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts and subscriptions (as applicable), support will be available under the terms and conditions of customers' service contract and subscription.

Starting with Secure Network Analytics Release 7.5.3, the SAL-OP (Secure Analytics Logging - On Prem) license is no longer required for integrating Secure Network Analytics with Secure Analytics On-Prem Logging from Cisco Firewalls. Instead, usage will now contribute to a customer's Flow Rate License, streamlining the entitlement process.

End of Change/Renewal Date* Subscription	The last date to Renew or Add to an existing subscription.	December 25, 2025
Last Date of Support** Subscription	The last date to receive applicable subscription entitlements, service and support for the product as entitled by active subscriptions and service contracts(as applicable) or by warranty terms and conditions. After this date, all subscription and support services for the product are unavailable, and the product becomes obsolete.	September 30, 2028
