

## Unrestricted Export Classification for Cisco Catalyst 4500 Series Supervisor Engines, Cisco Catalyst 4900 Fixed-Configuration Switches, and Cisco Catalyst 4900M Switch Overview

This product bulletin announces that Cisco® Catalyst® 4500-E and 4500 Series Switches, Cisco Catalyst 4900 Series Switches, Cisco Catalyst 4900M Switch and associated line cards chassis and power supplies have received an unrestricted export classification from the U.S. Department of Commerce, which means that, in most cases, government customers in countries located outside the EU “License-Free Zone” in APAC, CIS, and LATAM regions are authorized to obtain these SKUs without the associated U.S. export license requirement. Table 1 lists the exceptions for this classification within the Cisco Catalyst 4500, 4900 and 4900M families.
