Cisco announces the end-of-sale and end-of-life dates for the Cisco ME 2600X Series Ethernet Access Switches. The last day to order the affected product(s) is June 16, 2015. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.
