## End-of-Sale and End-of-Life Announcement for the Cisco Subscriber Feature Proxy

Cisco Systems® announces the end-of-sale and end-of life dates for the Cisco Subscriber Feature Proxy. The last day to order the affected product is February 8, 2007. Milestone	Definition	Date
<b>End-of-Life Announcement Date</b>	The date the document that announces the end of sale and end of life of a product is distributed to the general public.	August 10, 2006
<b>End-of-Sale Date</b>	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	February 8, 2007
<b>Last Ship Date: App SW</b>	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	May 9, 2007
<b>End of Software Maintenance Releases Date: App SW</b>	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software.	February 8, 2008
<b>End of New Service Attachment Date: App SW</b>	For equipment and software that is not covered by a service-and-support contract, this is the last date to order a new service-and-support contract or add the equipment and/or software to an existing service-and-support contract.	February 8, 2008
<b>End of Service Contract Renewal Date: App SW</b>	The last date to extend or renew a service contract for the product.	May 6, 2009
<b>Last Date of Support: App SW</b>	The last date to receive service and support for the product. After this date, all support services for the product are unavailable, and the product becomes obsolete.	February 7, 2010
