

## End-of-Sale and End-of-Life Announcement for the Cisco Unified Enterprise Attendant Console Versions 3.0, 3.1, and 8.0

Cisco announces the end-of-sale and end-of-life dates for the Cisco® Unified Enterprise Attendant Console Versions 3.0, 3.1, and 8.0. The last day to order the affected product(s) is August 22, 2011. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.

**IMPORTANT:** Please note that the Cisco Unified Enterprise Attendant Console (product number CUE-ATT-CON) is still orderable in the Cisco ordering tool. This end-of-sale and end-of-life announcement is meant only to communicate the discontinuation of older versions of the product - not the product as a whole.

<b>End of Service Contract Renewal Date: App. SW</b>	The last date to extend or renew a service contract for the product.	November 17, 2013
<b>Last Date of Support: App. SW</b>	The last date to receive service and support for the product. After this date, all support services for the product are unavailable, and the product becomes obsolete.	August 31, 2014
