



End-of-Sale and End-of-Life Announcement for the Cisco Compact Nodes

Cisco announces the end-of-sale and end-of-life dates for the Cisco Compact Nodes. The last day to order the affected product(s) is April 28, 2018. Customers with active service contracts or active warranties will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active service contracts or active product warranties, support will be available for the shown dates as stated in the applicable service contracts or product warranty terms and conditions.

The Cisco Compact Node products are being announced for discontinuation. The final order dates for this equipment is being timed to coincide with the availability of the next generation Compact Intelligent Node which is planned for release in early calendar year 2018.
