Cisco announces the end-of-sale and end-of-life dates for the Cisco DCM Series Dual-Layer Multi-Format Processor (MFP) Card. The last day to order the affected product(s) is September 30, 2016. For customers with active service contracts or active product warranties, support will be available for the shown dates as stated in the applicable service contracts or product warranty terms and conditions.

Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	December 29, 2016
