Cisco announces the end-of-sale and end-of-life dates for the Select Cisco D9865-B and D9865-H Satellite Receivers. The last day to order the affected product(s) is April 30, 2014. For customers with active service contracts or active product warranties, support will be available for the shown dates as stated in the applicable service contracts or product warranty terms and conditions, even if this date exceeds the Last Date of Support shown in Table 1.
