

## End-of-Sale and End-of-Life Announcement for the Prisma II Single-Wide CCB2-Based EDFAs

Cisco announces the end-of-sale and end-of-life dates for the Prisma II Single-Wide CCB2-Based EDFAs. The last day to order the affected product(s) is April 23, 2012. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active service contracts or active product warranties, support will be available for the shown dates as stated in the applicable service contracts or product warranty terms and conditions, even if this date exceeds the Last Date of Support shown in Table 1.

<b>Last Ship Date: HW</b>	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	July 22, 2012
