



## End-of-Sale and End-of-Life Announcement for the Prisma II Power Supply CE Version (Class II)

Cisco announces the end-of-sale and end-of-life dates for the Prisma II Power Supply CE Version (Class II). The last day to order the affected product(s) is October 19, 2012. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.

<b>Last Ship Date: HW</b>	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	January 17, 2013
<b>End of Routine Failure Analysis Date: HW</b>	The last-possible date a routine failure analysis may be performed to determine the cause of hardware product failure or defect.	October 19, 2013
