



## End-of-Sale and End-of-Life Announcement for the Cisco 3310 Mobility Services Engine

Cisco announces the end-of-sale and end-of-life dates for the Cisco 3310 Mobility Services Engine. The last day to order the affected product(s) is March 19, 2013.
