



End-of-Sale and End-of-Life Announcement for the Cisco InTracer

Cisco announces the end-of-sale and end-of-life dates for the Cisco InTracer. The last day to order the affected product(s) is January 30, 2015. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

This end-of-life announcement applies to the entire Cisco InTracer product line, across all InTracer releases and across all InTracer customers.
