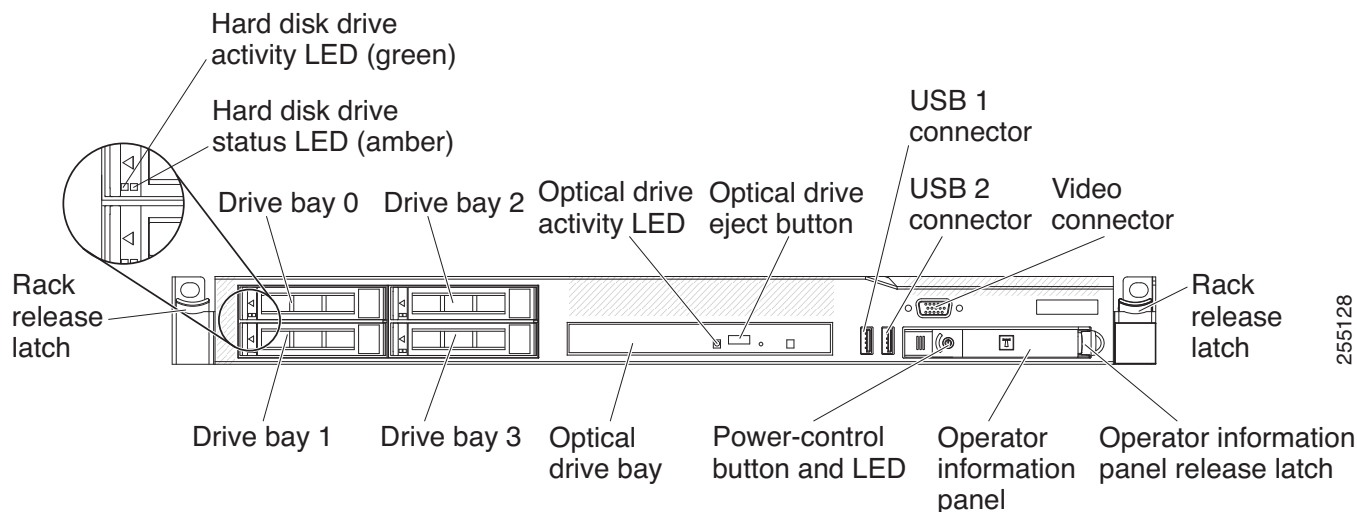
Cisco Prime Infrastructure Appliance
