## **Administration Console**

Unified Intelligence Center is installed on a Cisco Unified Operating System platform as a cluster with a maximum of eight nodes: one Controller node and up to seven Member nodes.

The Controller node is mandatory and provides both the Administration and the Unified Intelligence Center Reporting web applications. A cluster can consist of the Controller node only.

Member nodes are optional and have the Unified Intelligence Center Reporting application only. (Unified Intelligence Center Administration is not available on a Member node.)

The Administration console manages all components in a unified deployment and also provides links to:

- Cisco Unified Serviceability and SNMP
- Disaster Recovery System
- Real Time Monitoring Tool (RTMT)

## **Access Administration Console**

The System Application User who is defined during the installation is by default the initial Super User who can sign in to the Administration Application.

This initial Super User can then create other Super Users in the **Admin Users** page. For more information, see *Manage All Super Users*.



**Note** When you log in to the Admin Console site and you do not have any scheduled backup configured and enabled, Unified Intelligence Center returns the message "No active backup schedule is available. Set up a new schedule now." Unified Intelligence Center displays this message only for the administrator.

To access the Administration console:

#### Procedure

- **Step 1** Direct your browser to the URL *https://<HOST ADDRESS>/oamp* where *HOST ADDRESS* is the IP Address or Hostname of your server.
- Step 2 Sign in using your Super User (system application user) ID and password. A successful sign-in launches the OAMP application.

The session timeout for inactivity is thirty minutes. It is not configurable.

### Users in the Administration Console

There are three user accounts that have access to the Administration console:

- Super Users
- System Application User
- System Administration User

### **Super Users**

This user role is defined in the Administration console. It is the only user role for Administration.

The initial and default Super User is the System Application User who is configured during installation.

The initial Super User (the System Application User) can sign in to the Unified Intelligence Center Reporting console and has *all* User Roles and *full permissions* for all drawers in Unified Intelligence Center Reporting. Those credentials cannot be removed from the initial Super User.

Additional Super Users who are added in the Administration Console can also sign in to Unified Intelligence Center Reporting and are considered to be IMS users. They have limited Login User role only, until the Unified Intelligence Center Reporting security administrator gives them additional roles and flags them as Active users.

Local users can log in using their IMS username and password. After logging in for the first time, the users are listed on the User List Page. The username is not case sensitive, but the password is case sensitive.

### **System Application User**

This user role is defined during installation. Although it is possible to define unique application user names and passwords during the installation of each node, you must use the same credentials for all installations.

The application user defined during the installation of the *Controller* is the only System Application User recognized by Unified Intelligence Center.

This user has full rights to all functions in the Administration and Unified Intelligence Center Reporting applications, as described below:

- Can log in to the Administration application and becomes the initial Super User for Administration.
- · Can create additional Super Users in the Administration application.
- Can log in to Unified Intelligence Center and has full rights to all functions in Unified Intelligence Center.
- Is the initial Security Administrator user in the Unified Intelligence Center Reporting application.

- Can create additional Security Administrator users in the Unified Intelligence Center Reporting application.
- Cannot have any role taken away from them.
- Cannot take any role away from himself.
- This user can log in to the Reporting application and is the initial System user.

### System Administration User

The System Administrator account User ID and password are configured at installation for each node. You must enter the same user name and password for all nodes.

The System Administrator for the Controller can access:

- The Cisco Systems tools on the Navigation drop-down menu in the Administration console: Disaster Recovery System, Cisco Unified Serviceability, and Cisco Unified OS Administration interfaces.
- The CLI for the Controller.

The System Administrator has no access to functions in the Unified Intelligence Center Reporting application.



If you configure unique System Administrator credentials for Member nodes, use those credentials to access the CLI for those Member servers.

## **Unified Intelligence Center Cluster**

Unified Intelligence Center is installed as a cluster of at least one and up to eight nodes.

### Nodes in the Unified Intelligence Center Cluster

The first node in the Unified Intelligence Center cluster is the Controller. For database replication, this node is referred to as the "publisher". This means that it *publishes* or replicates, its databases to Member nodes.

The Member nodes are referred to as *subscribers* of the database replication. Members receive data from the publisher.

Each node on which reporting functionality is processed (the Controller node and each member node) has a Unified Intelligence Center database which is constantly accumulating and removing records; for example, when a dashboard is added or a user record is removed.

When all nodes are up, changes to the Unified Intelligence Center databases replicate synchronously among the Controller/publisher and all Member/subscribers by means of an "update anywhere" model. For more information, see *Database Replication*.

The Disaster Recovery System performs the database maintenance. For more information, see *Disaster Recovery System*.

## **Unified Intelligence Center Cache**

Unified Intelligence Center uses a cache to optimize access to the local Cisco Unified Intelligence Center database and it is built on top of the local configuration database. Unified Intelligence Center is designed to provide a highly scalable cluster in which every node manages its own local cache independently of other nodes.

When an item stored in the local cache (such as a report template or a dashboard) is modified, a message is sent to other nodes in the cluster indicating that the item has been modified and that their version of that item is stale. On receipt of this message, each node invalidates its own references to the stale item in the local cache. In this manner, all nodes remain synchronized.

In a few exceptional cases where, stale data can be re-cached or become out of synch in the cluster. Therefore, the Unified Intelligence Center System Configuration administrator has access to the **Synchronize Cluster** link below the username on the top-right corner of your user interface screen.

Click and confirm. This action notifies all nodes in the cluster to clear their local cache, and it synchronizes and empties all caches in the cluster. Clearing the locale cache forces each node to go directly to the database for the requested information.

Each node gets fresh data from the database. The data is automatically put into the local cache and accessed during future requests. Data will be consistent in the database, and there will be no loss of information.



**Note** It is best to perform this action during off-hours.

## Unified Intelligence Center—User Sessions

You can configure the maximum number of concurrent sessions a Unified Intelligence Center user can log in to. If a user reaches the configured limit, further login attempts are rejected. The maximum number of concurrent sessions is configured by using the **set webapp session maxlimit** command. For more information about this command, see the *Command Line Interface Reference Guide for Cisco Unified Communications Solutions* at https://www.cisco.com/c/en/us/support/unified-communications/unified-communications/unified-communications/

If a Unified Intelligence Center user reaches the maximum configured session count, that user can log in to another session only after signing out from an active session or if an active session times out due to inactivity. The session timeout duration is configured by using the **set cuic properties session-timeout** command. For more information about this command, see set cuic properties.

## **User Management**

Choose User Management in the left navigation pane to access the User Management page, where you view and maintain the Super Users for the Administration console.

*Super Users* are authorized to add and maintain the functions that are controlled in the Administration console, such as adding devices and starting or stopping services.



Super Users can also sign in to Unified Intelligence Center Reporting.

## **Manage All Super Users**

The **User Management** page is a list of the names for all configured Super Users in the system. This list always contains at least one row that shows the System Application User who is configured during installation and who becomes the initial Super User for Unified Intelligence Center. ### **Super Users and Security**

There is no limit to the number of additional Super Users that the default Super User (the System Application User) can create.

Although only the initial, default Super User (the System Application User) has full permissions in Unified Intelligence Center Reporting, *all* Super Users have *identical permissions in the Administration console*.

- Logs contain predefined, higher-level messages that can indicate everything from general system behavior to severe error conditions.
- Traces are free-form, developer-oriented, detailed information that is not printed to the logs by default, but only when increased logging is enabled to debug problems.

You configure log levels to be *Basic* or *Detailed*. *Basic* is the default. When you change the log levels to *Detailed*, you have the opportunity to select specific trace level definitions.

There are two ways to review log and tracing information:

- The Command Line Interface. Using the show trace command.
- The Real Time Monitoring Tool (RTMT).

This section provides the steps to change the IP address or hostname on a Cisco Unified Intelligence Center server. You may want to change this IP address for a variety of reasons, which include moving the server from one segment to another or resolving a duplicate IP address problem.

### **IP Address Change Checklist**

Perform the following tasks to ensure that your system is prepared for a successful IP address change.

If you have a DNS configured anywhere on the Unified Intelligence Center servers, ensure the following before changing the IP address:

- There is a forward and reverse lookup zone configured.
- The DNS is reachable and working.

Note

If you do not receive the results that you expect when you perform these tasks, do not continue with this procedure until after you resolve any problems that you find.

### **Prepare for IP Address Change**

You must perform the following tasks before changing the IP address.

#### Procedure

**Step 1** List all servers in the cluster and note whether the nodes are defined by using IP addresses or host names.

- a) From the Administration console on the first node, navigate to **Device Configuration**. System displays a list of all servers in the cluster.
- b) Capture this list of servers for later reference.
- **Step 2** Ensure that you have saved an inventory of both the host name and IP address of each node in your cluster.
- **Step 3** Ensure that all servers in the cluster are up and available by checking for any active ServerDown alerts. You can check by using either the Real Time Monitoring Tool (RTMT) or the Command Line Interface (CLI) on the first node.
  - To check by using RTMT, access Alert Central and check for ServerDown alerts.
  - To check by using the CLI on the first node, enter the following command and inspect the application event log:

file search activelog syslog/CiscoSyslog ServerDown

- **Step 4** Check the DB replication status on all the Unified Intelligence Center nodes in the cluster to ensure that all servers are replicating database changes successfully. You can check by using either RTMT or a CLI command.
  - To check by using RTMT, access the Database Summary and inspect the replication status.
  - To check by using the CLI, enter the command that is shown in the following example:

- 2-Replication is good.
- 3-Replication is bad in the cluster.
- 4-Replication setup did not succeed.
- **Step 5** To check network connectivity and DNS server configuration, enter the CLI command that is shown in the following example:

This section describes how to change the hostname for the Unified Intelligence Center Publisher (Controller) Node that is defined by an IP address.

### Procedure

**Step 1** Change the DNS record of the subscriber server to point to the new IP address. If the IP address is being changed at the same time, ensure that the DNS servers also reflect the IP address. Ensure that forward (A) and reverse (PTR) records update correctly.

**Note:** DNS servers comprise part of the network infrastructure. Unified Intelligence Center servers don't and can't run DNS servers.

**Step 2** If the server for which you're changing the hostname is a publisher server, log on to each subscriber server in the cluster and change the hostname mapping of the cluster Publisher server. You can perform this task from Cisco Unified Operating System Administration or by using a CLI command.

To change the mapping from Unified Intelligence Center Operating System Administration, log in to each subscriber server in the cluster and perform the following tasks:

- Step 3 Change the hostname of the server from Cisco Unified Operating System Administration:
  - a) Navigate to **Settings** > **IP** > **Ethernet**.
  - b) Change the hostname to the new hostname.
  - c) Click Save. The server automatically reboots with the new changes.
  - **Note** Changing the hostname triggers an automatically self-signed certificate regeneration. If your cluster is using CA-signed certificates, you must have them re-signed. For regenerating SAML certificate, refer to the **Hostname or IP Address Change** section in the Cisco Unified Contact Center Enterprise Features Guide.
- **Step 4** If the IP address changes along with the hostname and the server moves to a new subnet, change the server Default Gateway to the new address by using the set network gateway ip address CLI command.

If the default gateway changes, before the next step, ensure that the server moves to the new subnet and has access to the default gateway. During Unified Intelligence Center server startup, the Verify Network script checks server access to the default gateway. If the server can't communicate with the default gateway at startup time, the Verify Network script fails and start up may be delayed. If you're using Manual DHCP configuration

and the DHCP server isn't reachable or doesn't give out an IP address to the server, the system won't boot; instead, the system continues to wait at the Verify Network startup phase.

**Step 5** Reboot all other servers in the cluster twice, including the publisher.

**Step 6** Verify that the name-IP association change that was made in Step 4 propagates to the other nodes by using the utils network host and show tech network hosts CLI commands on all cluster nodes.

**Step 4** Update RTMT custom alerts and saved profiles:

- RTMT custom alerts that are derived from performance counters include the hard-coded server IP address. You must delete and reconfigure these custom alerts.
- RTMT saved profiles that have performance counters include the hard-coded server IP address. You must delete and re-add these counters and then save the profile to update it to the new IP address.

### **Configure IPv6**

Cisco Unified Intelligence Center supports IPv6 using dual stack (IPv4 and IPv6). You can enable IPv6 after installation using the either Cisco Unified Communications Operating System Administration or CLI.

With IPv6 enabled, the Unified Intelligence Center Administration Console and REST APIs can connect to the Unified Intelligence Center server using IPv4 or IPv6.

**Note** After installation, if you are not using IPv6 or IPv6 address is not assigned, disable the IPv6 service.

### Set up IPv6 using CLI

To set up IPv6 using the CLI, perform the following procedure on the primary and secondary servers of Unified Intelligence Center.

**Step 1** Access the CLI on the Unified Intelligence Center server.

- **Step 2** To enable or disable IPv6, enter: **set network ipv6 service {enable | disable}**.
- **Step 3** Set the IPv6 address and prefix length : **set network ipv6 static\_address** *addr mask*. Example: set network ipv6 static\_address 2001:db8:2::a 64
- **Step 4** Set the default gateway : **set network ipv6 gateway** *addr*
- **Step 5** Restart the system for the changes to take effect : **utils system restart**
- **Step 6** To display the IPv6 settings, enter : **show network ipv6 settings**

The IPv6 configured is global.

## **Configure Active Directory Settings**

Fields on the Active Directory tab configure the Active Directory server to authenticate reporting users as they log in to the Unified Intelligence Center Web application.

Configure Active Directory for the Unified ICM/CC supervisors so that they can sign in as Unified Intelligence Center Reporting users.



**Note** Cisco Unified Intelligence Center uses LDAP V2 which does not support all Unicode characters that are used in the first name or surname of LDAP users.

Active Directory is not used to authenticate Administration Super Users. These Super Users can only be authenticated through the local database. The first Super User is added during installation. All other Super Users are added through the **User Management** interface, and their credentials are encrypted into the local database.

Step 6	Use the utils service restart Cisco Tomcat and the utils service restart Intelligence Center Reporting Service CLI commands to restart the <i>Cisco Tomcat</i> and <i>Intelligence Center Reporting</i> services respectively.

## **Unified CCE User Integration**

### Note

The UCCE User Integration option is not applicable for Packaged CCE deployments.

The Unified CCE User Integration feature imports supervisors and their teams from Unified ICM/CCE from the Unified ICM Configuration Manager and database into Unified Intelligence Center.

Supervisors are automatically given Unified Intelligence Center user roles and can log in to Unified Intelligence Center to access collections for - and run reports for - their agent team(s).



- **Note** There are five tasks in the initial setup for Unified CCE User Integration. Some are performed in the Administration interface. Some are performed in the Reporting interface. As Super Users have access to both interfaces, it is efficient for a Super User to set up Unified CCE User Integration.
  - Enable Unified CCE User Integration in the Administration interface.
  - Complete the configuration of the Unified CCE Historical Data Source in the Configure > Data Sources of the Reporting Interface.
  - Synchronize Users in the Administration Interface.
  - Validate Collections of Agents and Agent Teams in the Reporting Interface.
  - Set up a synchronization schedule in the Administration Interface.
  - Integrated Supervisors can sign in to Unified Intelligence Center Reporting (provided their Active Directory authentication has been configured.
  - Integrated Supervisors are added to the Unified Intelligence Center Reporting User List with the User Roles of Report Designer and Dashboard Designer.
  - The Unified Intelligence Center Value Lists page is updated with Agents and Agent Teams collections.
  - Integrated Supervisors can view their Agents and Agent Teams collections (Unified Intelligence Center Reporting > Value Lists).
  - Integrated Supervisors are granted permissions to Agents and Agent Teams collections only.

After Unified CCE User Integration schedule is set up, Unified Intelligence Center is updated with changes to supervisors and their teams every time the synchronization updates.



- **Note** Renaming an existing Unified CCE user to a name that is identical to the locally created Unified Intelligence Center user and performing user integration results in the following:
  - All the entities that are owned by the locally created Unified Intelligence Center user are assigned to the synched Unified CCE user in Unified Intelligence Center.
  - The locally created Unified Intelligence Center user is deleted.

**Note** After upgrading to Cisco Unified Intelligence Center 12.6, perform the User Integration operation (Cluster Configuration > UCCE User Integration) manually to import the Supervisors with the required roles. This setting is required to view gadgets in the Cisco Finesse Desktop for Supervisors.

If the changes made to the Supervisors or teams are to be reflected immediately, then manually synchronize using the **Synchronize Now** option.

To navigate to this page, choose Cluster Configuration > UCCE User Integration.

The User Integration feature facilitates the automatic import of reporting supervisors who are added or modified in Unified ICM Configuration Manager and stored in the Unified ICM/CCE/CCH database.

Once integrated (imported), supervisors are added as users to the Unified Intelligence Center database and can sign into Unified Intelligence Center with their User ID and Password. They are created as users in Unified Intelligence Center with the User Roles of Dashboard Designer and Report Designer and with the rights to view the collection(s) for their agent team(s).

When Unified CCE User Integration runs, data is retrieved from the Unified CCE Data Source and two stock Value Lists (Agents and Agent Teams) are updated.



Warning

Schedule Unified CCE User Integration at off-peak hours and several hours after the database purge. By default, the purge runs at midnight (12:00:00 AM). Database tables are locked during the purge and are unlocked when the purge completes. If the Unified CCE User Integration runs at the same time as the purge, the user integration will fail.

## **Cluster Configuration for JVM Using Hazelcast**

Cisco Unified Intelligence Center uses Hazelcast for application clustering. Hazelcast provides a second-level cache for the Unified Intelligence Center application layer. When any entity (for example: report, report definition, and so on) cached by Hazelcast is updated in one of the Unified Intelligence Center nodes, it must be invalidated and reloaded in all the other Unified Intelligence Center nodes in the cluster. The Hazelcast cluster automatically takes care of it by publishing clusterwide notifications containing the identifiers of such entities which must be invalidated.

In Unified Intelligence Center, the default mechanism for Hazelcast cluster discovery or formation is UDP multicast. Unified Intelligence Center uses the Multicast group IP address 224.2.2.3 and port 54327. You cannot change these settings in Unified Intelligence Center.

The UDP multicast based discovery mechanism will not work for the customer in the following scenarios:

- When the network has multicasting disabled.
- If the nodes in the Unified Intelligence Center cluster are in different subnets.

In such scenarios, you can change the discovery mechanism to TCP/IP. You can form the CUIC application cluster using TCP/IP instead of the default UDP Multicast based discovery mechanism.

Use the following CLI commands to manage the cluster mode (UDP Multicast vs TCP/IP). That is, use the following CLI commands to switch to TCP/IP only if the customer's network does not support Multicasting:

• **utils cuic cluster show**—This command shows the current cluster mode that is enabled on this node and the other member details.



**Note** The member details are available only in the TCP/IP mode. The member details displayed are of the configured members and does not represent the cluster in real time.

• **utils cuic cluster mode**—This command is used to switch the Hazelcast cluster join configuration from Multicast to TCP/IP and the opposite way.



**Note** After changing the cluster mode in all the nodes, restart "Intelligence Center Reporting Service" in all the nodes starting from the publisher sequentially.

• **utils cuic cluster refresh**—This command refreshes the cluster member information only when run in the TCP/IP mode. Run this command when there is an addition or deletion of nodes to the CUIC cluster, which is already in TCP/IP.

#### Usage

You can use these commands using to switch to TCP/IP only when the customer's network does not support the Multicasting requirements that are specified in *Port Utilization Guide for Cisco Unified Contact Center Solutions* > *Intracluster Ports Between Cisco Unified Intelligence Center* section available at https://www.cisco.com/c/en/us/support/customer-collaboration/unified-contact-center-enterpise/products-installation-and-configuration-guides-list.html.



Note

- Stop the "Intelligence Center Reporting Service" on all the Unified Intelligence Center nodes before
  performing cluster configuration changes using these CLI commands.
- When you have completed the cluster configuration changes on all nodes, use the "utils cuic cluster show" command to ensure that all nodes have identical configuration before starting "Intelligence Center Reporting Service" on any one of them.
- Unified Intelligence Center cluster / application will work only if all the nodes use the same mode-that is, either Multicast or TCP/IP. Mixed mode is not allowed.
- If the network is disconnected and after the cluster nodes retain the network, ensure to perform "synchronize cluster" from all the nodes after logging into the Unified Intelligence Center reporting application.


## **Troubleshooting Cluster Configuration**

Verify the Hazlecast Cluster Formation using Hazelcast REST client. To verify, replace <CUIC-IP> with the IP address of any CUIC member in the following URL.

http://<CUIC-IP>:57011/hazelcast/rest/cluster

The Unified Intelligence Center application cluster can be down in the following cases:

- Common Cases:
  - Node is not reachable
  - · Unified Intelligence Center Reporting Service is down
  - · Member/subscriber node is added in OAMP and the node installation is in progress
  - Hazelcast default Port 57011 is not enabled in Unified Intelligence Center nodes in the customer environment, which is used to communicate between cluster members.
- When multicasting is being used for the member discovery (Default method):
  - Network has UDP multicast disabled
  - UDP port 54327 used for Hazelcast member discovery is disabled
  - Multicast default group IP 224.2.2.3 is not allowed in the network
  - · CUIC nodes are distributed across different subnets



- When TCP/IP is being used for the member discovery:
  - Member/subscriber node is added in OAMP, but the cluster mode in the newly added node is not switched to TCP/IP from the default method 'multicasting'.

## **Real Time Monitoring Tool**

For Cisco Unified Intelligence Center, Live Data, and Cisco Identity Service (Cisco IdS), download the Real Time Monitoring Tool (RTMT) from the Cisco Unified Intelligence Center Administration page (**Tools** > **RTMT Plugin Download**).

Live Data and the Cisco IdS do not host the RTMT installer. For this reason, always connect to the Cisco Unified Intelligence Center Server and sign in to the Administration page to download the RTMT installer. You can, however, run the same RTMT client to connect to any of the Cisco Unified Intelligence Center, Live Data, or Cisco IdS servers (standalone or coresident).

RTMT runs as a client-side application. You can install RTMT on a Windows workstation or a Linux machine. RTMT is cluster-aware. RTMT provides critical service and performance monitoring (perfmon), trace/log collection and viewing, and Alert Management on the node for the IP address you request at launch. RTMT does not provide the status of all critical applications on all the nodes at the same time.

Use RTMT to:

- Monitor the health of the system by generating email alerts for objects whose values go above or below a threshold
- Collect and view traces
- View syslog messages
- Monitor performance counters

RTMT has extensive online help. Refer to it for information on alerts, schedule collection, performance monitoring, and collecting and downloading tracing and logging data.

## Launch RTMT

### Procedure

- Step 1 In the left navigation pane, choose Tools and then click RTMT Plugin Download.
- **Step 2** In the **RTMT Plugin** dialog box:
  - a) Select the Windows platform.
  - b) Click Download.
  - c) Run the file or save the CuicServRtmtPlugin executable file and then run it from the saved location.
  - d) Follow the prompts and click the buttons on the installation screens.

### Step 3 To launch:

a) Launch RTMT from the desktop icon.

- b) In the Host IP Address field, enter the IP address for the node you want to monitor.
- c) Accept the default port (8443).
- d) Check **Secure Connection**. You see an error if the Host IP Address is not found or there is no network connection.

- f) Enter the User Name and Password for a Super User. (Only a Super User can install RTMT.)
- g) Click OK to accept the default configuration.


### Figure 5: RTMT Alerts

## **The RTMT Interface**

The following RTMT system monitoring objects are available in the left pane of the RTMT page:

System Summary

Displays information on Virtual Memory usage, CPU usage, Common Partition usage, and the alert history log.

### Server

Server objects are:

- CPU and Memory Displays information on Virtual memory usage and CPU usage for the server.
- Process Displays information on the processes running on the server.
- Disk Usage Displays information on the disk usage on the server.
- **Critical Services** Displays the name of the critical service, the status (whether the service is up, down, activated, stopped by the administrator, starting, stopping, or in an unknown state), and the elapsed time during which the services have existed in a particular state for the server or for a particular server in a cluster (if applicable).

The Cisco Unified Intelligence Center services are listed under the **Intelligence Center** tab. The Live Data and Cisco IdS services are listed, along with the System services, under the **System** tab.

### Performance

Performance objects are:

• **Performance** - Performance monitoring allows you to monitor performance counters related to the Unified Intelligence Center server. You can continuously monitor a set of preconfigured objects and receive notification in the form of an email message. You can associate counter threshold settings to alter notification. Up to six perfmon counters in one chart for performance comparisons can be displayed. Performance queries can be used to add a counter to monitor. You can also save and

restore settings, such as counters being monitored, threshold settings, and alert notifications, for customized troubleshooting tasks.

- **Performance Log Viewer** Displays data for counters from perfmon CSV log files in a graphical format.
- Tools

Tools objects are:

- Alert Central Displays the history and status of every alert in the system. Click the Intelligence Center tab to see Unified Intelligence Center alerts, including those related to Cisco IdS.
- Trace & Log Central Allows you to browse or download trace and log files for a specific date range or absolute time.
- Job Status Shows the status of trace collection events.
- Syslog Viewer Allows you to view (by node) the system, application, and security logs.
- VLT Not applicable.
- AuditLog Viewer Allows you to view system audit logs.

## **Cisco Unified Intelligence Center Services**


- Intelligence Center Perfmon Service—Performance data collection process, which persists counters relating to Unified Intelligence Center report execution and live data statistics from Unified Intelligence Center, Socket.IO, and CCE Live Data ActiveMQ Service process, which will be helpful in debugging performance issues.
- Intelligence Center Reporting Service— Core service for the Unified Intelligence Center reporting functionality.
- Intelligence Center SNMP Java Adapter Service—SNMP service that interfaces between JMX counters and the SNMP Primary Agent.
- Intelligence Center Serviceability Service— Services that exposes RTMT counters from the Unified Intelligence Center server.

## Unified IC performance objects and counters

Unified Intelligence Center performance *objects* are named for system components that generate data. Each performance object provides performance *counters* that represent data specific to that object. The Unified Intelligence Center Reporting object has counters for the number of reports that are running and the number of reports that have failed. The counters for each object display when the folder expands.

**Reporting Counters.** The following diagram illustrates the runtime interactions and the relationship among the components involved on the execution of a report. The diagram provides a simple structure that defines the reporting engine performance counters.

#### Figure 7: Report Execution



When the data for the report is available, the Data Processing Center computes the formula fields and global report footers. The gauge, grid, and chart managers in the engine pre-process the data to generate subsets of information that will be consumed by their corresponding peer components on the User Interface. The diagram shows which processes have a high cost of execution and the importance of closely monitoring the operations performed by charts, grids, data processing center, the data sources, and so forth. Monitor these components to track the behavior of each component and its total contribution to the cost of executing a report.

Aggregating the costs of all components provides a holistic view of the system performance. Keeping counters at the component level allows the system and application administrator to drill down into the details to determine what each component is doing and to perform any necessary corrective actions that.

This section lists all the performance objects monitored for Unified Intelligence Center and explains the counters for each.

#### Intelligence Center Perfmon Service

Logs the performance counters from the critical processes in the system related to the Live Data Reporting services. This service collects data from the following services if they are up and running:

- Intelligence Center Reporting Service
- CCE Live Data ActiveMQ Service

Performance counter values are stored to the logs in the directory: /opt/cisco/cuic/logs/perfmon. The Intelligence Center Perfmon Service is configured to retain approximately 10 days of data at any given time. This service is independent of other services and is not required by other processes in the system.

## **Cisco Unified Intelligence Center Counters**

Counters:

### **CUIC Tomcat Connector**

The Tomcat Connector object provides information about Tomcat secure Hypertext Transport Protocol (HTTP) connectors. A Tomcat Connector represents an endpoint that receives requests and sends responses.

The Connector handles HTTP requests and sends HTTP responses that occur when Cisco Unified Intelligence Center web pages are accessed.

Counter	Description
Errors	The total number of HTTP errors (for example, 401 Unauthorized ) encountered by the Connector.

Counter	Description
MBytes Received	The total number of data received by the Connector.
MBytes Sent	The total number of data that the Connector has sent.
Requests	The total number of requests that have been handled by the Connector.
ThreadsBusy	The Connector's current number of busy/in-use request processing threads.
ThreadsMax	The Connector's maximum number of request processing threads.
ThreadsTotal	The Connector's current total number of request processing threads, including available and in-use threads.

### **CUIC Tomcat JVM**

The Tomcat Java Virtual Machine (JVM) object provides information about the Tomcat JVM, which represents, among other things, a pool of common resource memory used by Unified Intelligence Center.

Counter	Description
KBytesMemoryFree	The amount of free dynamic memory block (heap memory) in the Tomcat Java Virtual Machine. The dynamic memory block stores all objects created by Tomcat and its web applications such as Unified Intelligence Center. When the amount of free dynamic memory is low, more memory is automatically allocated and total memory size (represented by the KbytesMemoryTotal counter) increases up to the maximum (represented by the KbytesMemoryMax counter). You can determine the amount of memory in use by subtracting KBytesMemoryFree from KbytesMemoryTotal.
MemoryMax	The maximum dynamic memory block size for the Unified Intelligence Center Tomcat Java Virtual Machine.
MemoryTotal	This current total dynamic memory block size - including free and in-use memory - for the Tomcat Java Virtual Machine.

### **CUIC Tomcat Web Application**

The Tomcat Web Application object provides information about running Cisco Unified Intelligence Center. The instance name for each Tomcat Web Application is based on the URL for the web application.

Counter	Description
Errors	The total number of HTTP errors (for example, 401 Unauthorized) encountered by a Cisco Unified Intelligence Center related web application.
Requests	The total number of requests handled by the web application. Each time a web application is accessed, its Requests counter increments accordingly.

Sessions Active	The number of currently active (in use) sessions the web application currently has.

## **DB Change Notification Client**

Counter	Description
MessagesProcessed	The number of database change notifications that have been processed. This counter refreshes every 15 seconds by default.
MessagesProcessing	The number of change notification messages in the change notification queue for this client that are currently being processed or are waiting to be processed. This counter refreshes every 15 seconds by default.
QueueHeadCounter	The head pointer of the change notification queue. The head pointer is the starting point in the change notification queue. To determine the number of notifications in the queue, subtract the head pointer value from the tail pointer value. This counter refreshes every 15 seconds by default.
QueueMax	The largest number of change notification messages to be processed for this client. This counter is cumulative since the last restart of the Cisco Database Layer Monitor service.

# **Disaster Recovery System**

## **Backup and Restore Overview**

The Disaster Recovery System (DRS) provides full data backup for all servers in a Cisco Unified Intelligence Center cluster. It allows you to perform regularly scheduled automatic or user-invoked data backups.

The Disaster Recovery System performs a cluster-level backup, which means that it collects backups for all servers in a Cisco Unified Intelligence Center cluster to a central location and archives the backup data to physical storage device. Backup files are encrypted and can be opened only by the system software.

DRS restores its own settings (backup device settings and schedule settings) as part of the platform backup/restore. DRS backs up the drfDevice.xml and drfSchedule.xml files. When the server is restored with these files, you do not need to reconfigure DRS backup device and schedule.

The Disaster Recovery System includes the following capabilities:

- A user interface for performing backup and restore tasks.
- A distributed system architecture for performing backup functions.
- Scheduled backups or manual (user-invoked) backups.

## **Backup Prerequisites**

To back up data to a remote device on the network, you must have an SFTP server that is configured. You can use an SFTP server product that is certified with Cisco Technology Partners. Technology partners certify their products with specified versions of Cisco Unified Communications Manager. For information on which vendors have certified their products with your version of Cisco Unified Communications Manager, see the *Solutions Catalog* on the Cisco Developer Network at https://marketplace.cisco.com.

Ensure that all cluster nodes are running the same version of Cisco Unified intelligence Center. If different nodes are running different versions, the certificates will not match and your backup or restore could fail.



**Note** Retest the DRS with your SFTP server after you upgrade your Unified Communications Manager, upgrade your SFTP server, or you switch to a different SFTP server. Perform this step to ensure that these components operate correctly together. Additionally, perform a backup and restore on a standby or backup server.

Use the information in the following table to determine which SFTP server solution to use in your system.

**Note** While a backup or restore is running, you cannot perform any OS Administration tasks, because Disaster Recovery System blocks all OS Administration requests by locking the platform API. However, Disaster Recovery System does not block most CLI commands, because only the CLI-based upgrade commands use the Platform API locking package.

## **Backup Procedure Taskflow**

#### **Configure backup devices**

You can configure up to 10 backup devices. Perform the following steps to configure the location where you want to store backup files.

#### Before you begin

• Ensure you have write access to the directory path in the SFTP server to store the backup file.

• Ensure that the username, password, server name, and directory path are valid as the DRS Primary Agent validates the configuration of the backup device.

**Note** Schedule backups during periods when you expect less network traffic.

  - In the **Path name** field, enter the directory path where you want to store the backup file.
  - In the User name field, enter a valid username.
  - In the **Password** field, enter a valid password.
  - From the Number of backups to store on Network Directory drop-down list, choose the required number of backups.
- Step 5 Click Save.

### **Estimate Size of Backup Tar**

Cisco Unified Intelligence Center will estimate the size of the backup tar, only if a backup history exists for one more selected features.

The calculated size is not an exact value but an estimated size of the backup tar. Size is calculated based on the actual backup size of a previous successful backup and may vary if the configuration changed since the last backup.

You can use this procedure only when the previous backups exist and not when you back up the system for the first time.

Follow this procedure to estimate the size of the backup tar that is saved to a SFTP device.

#### **ThreadPool Events**

The thread pool information group defines the set of objects for the Unified reporting engine thread pool. All servers populate these objects.

Object	Description
ThreadsMaxAvailable	The maximum number of threads available to the Unified Intelligence Center web server thread pool manager.
ThreadsRunning	The number of threads that are currently running tasks.This counter is useful in monitoring performance of the server. If the number of threads is close to the maximum available, then the next reporting request must wait until a thread becomes free.

Object	Description
QueuedTasks	the number of queued tasks. A task is a job, performed by one or more thread.
QueuedTasksMax	The maximum number of queued tasks.

#### **EnvInfo Events**

The EnvInfo group defines the set of objects for the Runtime tomcat info. All servers populate these objects.

Object	Description
WaErrors	The total number of HTTP errors (for example, <i>401 Unauthorized</i> ) encountered by a Unified Intelligence Center web application.
WaSessionsActive	The number of currently active (in use) sessions for the web application.
JvmPercentCPUTime	The percentage of CPU utilized by the Tomcat JVM. This object is for the Unified Intelligence Center Tomcat JVM object .
JvmMemoryFree	The amount of free dynamic memory in the Unified Intelligence Center Tomcat Java Virtual Machine.
JvmMemoryTotal	The Tomcat Java Virtual Machine current total dynamic memory, including free and in-use memory.
JvmMemoryMax	The Unified Intelligence Center Tomcat Java Virtual Machine maximum dynamic size.
TomcatThreadsBusy	The Unified Intelligence Center Tomcat Connector current number of busy/in-use request processing threads.
TomcatThreadsTotal	The Unified Intelligence Center Tomcat Connector current total number of request processing threads, including available and in-use threads.
TomcatThreadsMax	This object indicates the Connector maximum number of request processing threads. Each incoming request on a Unified Intelligence Center web page requires a thread for the duration of that request. If more simultaneous requests are received than can be handled by the currently available request processing threads, additional threads will be created up to the configured maximum shown in this counter.

With release 12.6(1), Cisco Unified Intelligence Center lets the administrator configure the custom logon messages displayed when the users sign in.

To configure the custom message using Cisco Unified OS Administration console, perform the following steps:

**Note** The custom message can be uploaded to the server as a text file.

By default, there is no custom message configured. However, it is not mandatory to configure the message.

#### Procedure

- **Step 2** Navigate to **Software Upgrades** > **Custom Logon Message**.
- **Step 3** Click Choose File, to upload the customized message file.
- **Step 4** Select the file and click **Open**.
- Step 5 Click Upload File.

## Install Certificate Authority (CA) Certificate

To install or upload certificates on the Cisco Unified Intelligence Center server, perform the following steps:

#### Procedure

Step 1	Log in to Cisco Unified Operating System Administration.
Step 2	Navigate to <b>Security &gt; Certificate Management</b> . The <b>Certificate List</b> window appears.
Step 3	Click Generate CSR. The Generate Certificate Signing Request dialog box opens.
Step 4	Select <b>tomcat</b> from the Certificate Purpose list.
Step 5	Click Generate to generate a certificate from a custom or third-party certificate authority.
Step 6	Click Close.
Step 7	Click Download CSR.
Step 8	In the <b>Download Certificate Signing Request</b> screen, click <b>Download CSR</b> to download the Certificate Signing Request to your computer.
Step 9	Use this CSR to obtain the Public certificate and Primary certificate from the Certificate Authority.
Step 10	Log in to OS platform again and navigate to Security > Certificate Management.
Step 11	Click Upload Certificate/Certificate chain. The Upload Certificate/Certificate chain dialog box opens.
Step 12	To upload the certificate chain, select tomcat from the Certificate Purpose list.
Step 13	Select the file to upload. Click the Choose File button and navigate to the file; then, click Open.
Step 14	Click Upload.
Step 15	After successfully uploading the certificate, navigate to Security > Certificate Management.
Step 16	Click <b>Find</b> to open the list of certificates.
Step 17	Click on the uploaded certificate to view Certificate File Data.
Step 18	Restart the node(s) using the CLI command utils system restart.



- To upload a custom certificate with alternate hostname, set the alternate hostname using the CLI command *set web-security*. Configure the alternate hostname and use the procedure above to generate Certificate Signing Request (CSR) and to upload the certificates. You can access Cisco Unified Intelligence Center by using the alternate hostname as well.
- To avoid the certificate exception warning, you must access the servers using the Fully qualified domain name (FQDN) name. That is, leave the **Distribution** field in the CSR as the FQDN of the server.
- Ensure that the Certificate Authority (CA) certificate is RSA-signed.
- Cisco Unified Intelligence Center CSR certificates are signed with *sha1WithRSAEncryption* using a 2048-bit RSA public key.
- Cisco Unified Intelligence Center does not support wildcard certificates.

### **CUIC Server Certificates**

Two server certificates — *intelligencecenter-jms* and *intelligencecenter-srvr*, even though available, are not used anymore. There is no impact even if these certificates expire, and it is not required to regenerate them.

### Access Platform Web Applications using Chrome Browser

This section is applicable only if you are using Chrome based browsers (Google Chrome or Edge Chromium) to access the Platform web applications, such as Cisco Unified OS Administration, Cisco Unified Serviceability or Disaster Recovery System.

This section is also applicable for Cisco Unified Intelligence Center Administration web application on CUIC nodes.

If you are using self-signed certificates, add the certificates to the Client OS trust store to access the administrative web applications.



Note

Chrome needs the self-signed certificate to have **Subject Alternative Name** extension to load the administrative web applications. If the self-signed certificate does not have **Subject Alternative Name**, regenerate the certificate from Cisco Unified OS Administration.

### Download the Server Certificate from CUIC Node

This section provides instructions to download the server certificate from CUIC node.

# **Command Line Interface**

The Command Line Interface (CLI) provides a set of commands applicable to the operating system, to the Unified Intelligence Center database (*cuic\_data*) and to the system database (*ccm\_<version>*).

These commands allow basic maintenance and failure recovery and also enable some system administration when the Unified Intelligence Center operations console is unavailable.

You can access the CLI directly, using the monitor and keyboard at the server console:

- 1. Enter the ID for the System Administration user (the one created during install).
- 2. When prompted, enter the password for the System Administration user.

In addition to the CLI commands listed in this chapter, you can also enter:

- help to display the list of all supported commands. For example, to display help for a specific command, type help delete dns and press Enter.
- quit to close the CLI.

In the command syntax descriptions:

**bold** is used for the base command.

italics are used for mandatory parameters, when the syntax includes them.

[] brackets are used for options, when the syntax includes them.

### **Unset Command**

### unset cuic properties

Use this command to remove the translation of host-to-ip setting.

Command Syntax unset cuic properties host-to-ip hostname

### unset ipsec

Use these commands to disable ipsec policies.

**Command Syntax unset ipsec policy\_group** [{groupall}] Use to disable all policies within a group or all groups.

#### **Command Syntax**

**unset ipsec policy\_name** [*policy\_group*] [*policy\_name*] Use to disable a policy with a given policy name and group. For example, set ipsec policy\_name group1 name1.

### unset network dns

#### **Command Syntax**

**unset network dns options** [*options*] This command removes the DNS options setting and causes a temporary loss of network connections.

OPTIONS:

[timeout] sets the wait time before the system considers a DNS query failed to the default.

[attempts] sets the number of DNS attempts to make before failing to the default.

[rotate] sets the method for selecting a nameserver to the default. This affects how loads are distributed across nameservers.

#### **Command Syntax**

**unset ipv6** [*policy\_group*] [*policy\_name*] These commands disable the policy group or all groups, or a policy with a specified group and name.

### unset\_host-to-ip

Use this command to remove any host-to-ip configurations that were defined with the command set cuic properties, on page 149.

Running this command removes the node-specific override for the IP address of the Unified CCE databases and reverts to the default for the Unified CCE databases as configured in the Data Sources page.

Command Syntax unset\_host-to-ip

### **Utils Command**

### utils auditd

These commands display enable, disable, and show the status of the audit daemon.

When enabled, auditd log files for the system are retrievable through RTMT. The auditd system monitors for specific security sensitive system calls at the OS kernel level and provides a record-keeping trail for such activities as file permission changes, failures to manipulate files due to permission settings, and changes to the system time and name.

Command Syntax utils auditd disable utils auditd enable utils auditd status

### utils core

These commands display information for core files.

#### **Command Syntax**

**utils core analyze** *core\_file\_name* This command displays backtrace for the specified core file.

PARAMETER core\_file\_name.

#### **Command Syntax**

utils core list This command lists existing core files.

### utils create report

These commands create a system report. If you specify hardware, the report contains disk array, remote console, diagnostic, and environmental data.

If you specify platform, the system collects the platform configuration files and copies them to a common log location.

As these reports take time to complete, the system prompts for a confirmation.

Command Syntax utils create report hardware utils create report platform

### utils cuic

#### utils cuic cpudiagnostics

This command is to monitor cuic tomcat process continuously and report the CPU usage per thread. It uses a combination of top and jstack commands to find out CPU usage at thread level and merge the results into the standard jstack output.

Command Syntax utils cuic cpudiagnostics enable <max\_cpu>

This command is to enable cpu diagnostic process.

PARAMETERS:

Max CPU usage at which to log thread details, max\_cpu should be between 50 to 90. Default value is "50"

#### Command Syntax utils cuic cpudiagnostics disable

This command line is to disable the cpudiagnostics process.

#### utils cuic mbeans

#### **Command Syntax**

**utils cuic mbeans** [\_c] [\_e] [\_i <val>] [\_l <val>] [\_n] [\_o <val>] [\_p <val>] [\_u <val>] [\_v <val>] [\_x <val>]

PARAMETERS:

\_e, \_\_exitonfailure With this flag, terminal exits for any Exception

\_i,\_\_input <val> Input script file. There can only be one input file. Default value is "stdin"

\_l,\_\_url <val> Location of MBean service. It can be <host>:<port> or full service URL.

\_n,\_\_noninteract Non interactive mode. Use this mode if input doesn't come from human or jmxterm is embedded

\_o, \_output <val> Comma separated output list, file and/or stdout. Default value is "stdout".

\_p, \_\_password <val> Password for user/password authentication

\_u,\_\_user <val> User name for user/password authentication

\_v,\_verbose <val> Verbose level, could be silent|brief|verbose. Default value is "brief".

\_x,\_\_execute <val> Executes a command (a connection must be opened first with \_l)



**Note** Without any option, this command opens an interactive command line based console. With a given input file, commands in file are run and process ends after file is processed. The execute option may be used to run a command directly, without opening the interactive command line. If the command requires an open connection, it must be opened with \_l. Quotes may be used to group words in the command and any dashed arguments use underscore instead.

#### utils cuic nmon

#### **Command Syntax**

utils cuic nmon start s [seconds] c [count]

PARAMETERS:

s specifies the time interval (in seconds) between each collection.

*c* specifies the number of collections that you want to invoke. Each collection takes up about one Kilobyte of disk space.

#### **Command Syntax**

#### utils cuic nmon stop

This command stops the nmon capture. The data that is captured in this nmon session is savedin/common/log/installin nmon\_output.nmonfile.

#### utils cuic purge

This command runs a manual purge of the cuic database tables. You might do this if you receive an alert that the database is nearing capacity and you do not want to wait for the daily automatic purge.

The tables purged are:

- CuicDataSetInfo
- CuicDataSet
- CuicReportDefinitionFilter
- CuicReportDefinitionFilterField
- CuicReportDefinitionFilterParameter
- CuicCollection
- CuicCollectionValue

This command prompts for the password of the administration user. When the password is confirmed, the purge runs immediately.

#### utils cuic restorepub

This command restores security files like keypassfile and cuickeystore files from subscriber to publisher in the same cluster.

#### Command Syntax utils cuic restorepub

PARAMETERS:

No optional parameters.

#### utils cuic cors

(

**Important** After you make changes to the CORS status, allowed origins list, exposed header, or allowed header, restart Cisco Intelligence Center Reporting Service for changes to take effect. All CLIs are node-specific and must be run on all nodes in the cluster.

#### Command Syntax utils cuic cors enable

This command enables Cross Origin Resource Sharing (CORS) support in Unified Intelligence Center.



Note For Unified Intelligence Centre gadgets (Live Data and Historical) to load in Cisco Finesse, ensure to:

- Enable CORS using the utils cuic cors enable command.
- Set the Finesse host URL in the utils cuic cors allowed\_origin add URLs command.

#### utils cuic session delete

This command deletes the Cisco Unified Intelligence Center sessions based on the username that you pass to this command.

#### **Command Syntax**

utils cuic session delete <username 1,username 2>

#### Parameter

Usernames are names of the currently logged in users of the current Cisco Unified Intelligence Center sessions.

To get the current usernames, you must first run the utils cuic session list command and then run file view activelog cuic-session.out command.

### utils cuic cluster show

This command shows the current cluster mode enabled on this node and the other member details.

**Note** The member details are available only in the TCP/IP mode. The member details displayed are of the configured members and does not represent the cluster in real-time.

### utils cuic cluster mode

This command is used to switch the CUIC cluster join configuration from Multicast to TCP/IP and vice versa.

Note

After changing the cluster mode in all the nodes, restart "Intelligence Center Reporting Service" in all the nodes starting from the publisher sequentially.

Command Syntax utils cuic cluster mode

### utils cuic cluster refresh

This command refreshes the cluster node information only when run in the TCP/IP mode and must be run when there is an addition or deletion of nodes to the CUIC cluster.

Command Syntax utils cuic cluster refresh

### utils cuic logging

The **utils cuic logging** commands update or display the configuration only on the nodes on which the commands are run. To change the logging configuration on each node in the cluster, you must run the command separately on each node.

### utils cuic logging config set

This command sets the value for log file configuration.

#### Command Syntax utils cuic logging config set [config-name] [config-value]

#### Options

• [config-name] - mandatory log file configuration name

Valid configuration names are max-file-size, max-file-count, syslog-primary-host and syslog-secondary-host. The maximum limit of max-file-size and max-file-count is 50 MB and 50 respectively.

Only one [config-name] option can be set at a time.

• [config-value] - mandatory log file configuration value. For syslog-primary-host and syslog-secondary-host configuration names, the configuration values are the primary syslog server hostname and the secondary syslog server hostname, respectively.

#### utils cuic logging config show

This command prints the current log configuration for the given configuration name.

#### **Command Syntax**

utils cuic logging config show [config-name]

#### Options

[config-name] - mandatory log file configuration name

Valid configuration names are max-file-size, max-file-count, syslog-primary-host and syslog-secondary-host.

Only one [config-name] option can be printed at a time.

#### utils cuic logging config clear

This command clears the log file configuration for the primary and secondary syslog servers.

#### Command Syntax

utils cuic logging config clear [config-name]

#### Options

[config-name] - mandatory log file configuration name

Valid configuration names are syslog-primary-host and syslog-secondary-host.

Only one [config-name] option can be cleared at a time.

#### utils cuic logging list

This command lists the module and the logging level for the specified module. If a module name is specified, the logging level is displayed only for that module.

Command Syntax utils cuic logging list [module-name]

#### Options

[module-name] - optional

#### Possible module names for which, the log levels can be printed are as follows:

REPORT, REPORTENGINE, REPORTDEFINITION, SCHEDULER, DASHBOARD, AUTHORIZATION, AUTHENTICATION, VALUELISTCOLLECTION, SECURITY, CUICUI, DATASOURCE, CUICCONFIG

#### utils cuic logging reset

This command resets any modifications done to the logging configuration to the default value. For all the modules, the default value is Info.

#### Command Syntax utils cuic logging reset

#### **Options**

No parameters

### utils cuic logging update

This command updates the log level for the given module name.

#### Command Syntax utils cuic logging update [module-name] [log-level]

#### **Options**

• [module-name] - mandatory

Possible module names are as follows:

New log level for the module. Valid log-level values are as follows:

#### utils dbreplication rebuild

This command is used to set up database replication across the cluster. This command can only be run from the publisher. This command will run the following commands on the specified nodes:

### utils dbreplication repair

This command repairs mismatched data on a named node or between nodes. It does not repair replication setup.

#### utils dbreplication runtimestate

This command is used to monitor progress of the database replication process and provides replication state in the cluster.

OPTION: [nodename] limits the status to that of the node indicated.

#### utils dbreplication setrepltimeout

Use this command to increase the default timeout for replication setup on large clusters.

The default timeout is 5 minutes, thus all subscribers requesting replication within 5 minutes will be on the broadcast list and will be replicated.

#### **Command Syntax**

utils dbreplication setrepltimeout nteger value of new timeout in seconds

PARAMETER: integer value of new timeout in seconds must be between 300 and 3600 seconds.

#### utils dbreplication status

Use this command to view status of database replication after setup is complete. To monitor status during setup, use RTMT.

Command Syntax utils dbreplication status

#### utils dbreplication stop

This command is used to stop the automatic setup of database replication and to stop the ongoing setup of replication.

Run this command on each node where replication needs to be stopped.

Run on all Member nodes first and then on the publisher (the Controller node).

Run this command with no parameters to run the stop operation on the local node only.

On the publisher, run this command as stop all or stop nodename to run the stop operation on all nodes or on a named node.

Command Syntax utils dbreplication stop all utils dbreplication stop nodename

### utils diagnose

Use these commands for various diagnostic functions.

**Command Syntax utils diagnose fix** This command runs diagnostic tests, displays the results, and if possible, attempts to repair the system.

**Command Syntax utils diagnose list** This command lists all available diagnostic commands.

**Command Syntax utils diagnose module** *module name* This command runs a test on a named module test and attempts to fix the problem if possible.

**Command Syntax utils diagnose test** This command runs diagnostic tests and displays the results.

**Command Syntax utils diagnose version** This command displays the version of the diagnostics system.

### utils disaster\_recovery

#### utils disaster\_recovery backup

This command invokes a backup and makes the tar file on the network drive or the tape.

Command Syntax utils disaster\_recovery backup network <featurelist> <path> <servername> <userid >

PARAMETERS:

*featurelist* indicates the comma-separated feature list to back up. Use the command **utils disaster\_recovery show\_registration** to display the list of registered features.

*path* indicates the path to save back up files.

servername is the server ip/hostname where the backup file is to be stored.

userid is the user id used to connect to the remote machine.

utils disaster\_recovery backup tape <featurelist><tapeid>

PARAMETERS:

featurelist indicates a comma-separated feature list to back up.

*tapeid* indicates the tape ID to back up the files. Use the command utils **disaster\_recovery show\_tapeid** to display the list of tape IDs.

#### utils disaster\_recovery cancel\_backup

This command cancels an ongoing backup.

Command Syntax utils disaster\_recovery cancel\_backup confirm

confirm is mandatory and prompts you to enter Yes/Y to continue or any other key to stop.

#### utils disaster\_recovery device

#### **Command Syntax**

**utils disaster\_recovery device add network** *devicename path server\_namei/ip\_address username* [Number\_of\_backups]

This command adds the backup network device.

#### PARAMETERS :

devicename: Specifies the name of the backup device to be added (mandatory).

*path* : Specifies the path to retrieve the backup device (mandatory).

*server\_namei/ip\_address* : Specifies the hostname or IP address of the server where the backup file is stored (mandatory).

username : Specifies the userid required to connect to the remote location.

*Number\_of\_backups* : Specifies the number of backups to store on the Network Directory (default 2). This parameter is optional.

This command deletes the specified device.

#### PARAMETERS :

\* : Deletes all existing devices except for the ones associated to a schedule

Displays the device name, device type, and device path for all the backup devices.

#### utils disaster\_recovery estimate\_tar\_size

Command Syntax utils disaster\_recovery estimate\_tar\_size featurelist

PARAMETERS:

*featurelist* indicates the comma separated feature list to backup. Use **utils disaster\_recovery show\_registration** <**servername>** to display the list of registered features.

#### utils disaster\_recovery history

This command displays the history of previous backups and restores.

Command Syntax utils disaster\_recovery history [operation]

operation specifies backup and restore.

### utils disaster\_recovery jschLogs

Command Syntax utils disaster\_recovery jschLogs operation

PARAMETERS:

operation name of operation like Enable\Disable.

### utils disaster\_recovery prepare

This command prepares for backup and restore from publisher and subscriber.

Command Syntax utils disaster\_recovery prepare restore

Command Syntax utils disaster\_recovery prepare restore pub\_from\_sub

#### utils disaster\_recovery restore

These commands invoke a restore.

#### **Command Syntax**

**utils disaster\_recovery restore network** <*restore\_server> <tarfilename> <path> <servername> <userid>* 

PARAMETERS:

restore\_server is the hostname of the server to be restored.

*tarfilename* is the tar file name to be restored.

path is the mandatory path that retrieves the backup tar file from this location.

servername is the server ip\hostname from which to retrieve backup tar file.

userid is the user id used to connect to the remote machine.

#### **Command Syntax**

utils disaster\_recovery restore tape <server><tarfilename> <tapeid>

PARAMETERS

server is the hostname of the server to be restored.

tarfilename is the tar file name to be restored.

*tapeid* is the tape ID used to restore files from the tape device. Use the command **utils disaster\_recovery show\_tapeid** to display the list of tape IDs.

#### utils disaster\_recovery show\_backupfiles

These commands retrieve information about backup files.

#### Command Syntax utils disaster\_recovery show\_backupfiles network cyath> <servername> <userid>

#### PARAMETERS:

*path* indicates the location of the backup file.

servername is the server ip/hostname where the backup file has been stored.

userid is the user id used to connect to the remote machine.

#### **Command Syntax**

utils disaster\_recovery show\_backupfiles tape tapeid

PARAMETER: tapeid is the ID of the tape device.

#### utils disaster\_recovery show\_registration

This command shows all the registered features and components on a given server.

#### Command Syntax utils disaster\_recovery show\_registration

This command shows the list of tape IDs.

Command Syntax utils disaster\_recovery show\_tapeid

#### utils disaster\_recovery status

This command shows the status of the ongoing backup or restore operation.

#### Command Syntax utils disaster\_recovery status operation

PARAMETER operation is the name of the operation: backup or restore.

### utils firewall

These commands perform various actions pertaining to the firewall.

Command Syntax utils firewall disable [time] utils firewall enable

#### utils firewall list utils firewall status

OPTION: [time] is the duration in seconds for which the firewall is to be disabled.

#### utils firewall ipv4

These commands perform various actions pertaining to the firewall ipv4.

**Command Syntax utils firewall debug** [off \\ time]

PARAMETERS:

This command turns IPv4 firewall debugging on or off. If you do not enter a time parameter, this command turns on debugging for 5 minutes.

*off* Turns off the IPv4 firewall debugging. If you do not enter the time parameter, this command disables the firewall for 5 minutes.

time (Optional) Sets the duration for which the firewall debugging is to be enabled in the following formats:

- Minutes: 0-1440m
- Hours: 0-23h
- Hours and minutes: 0-23h 0-60m

### Command Syntax

utils firewall disable [time]

*disable* Turns off the IPv4 firewall. If you do not enter the time parameter, this command disables the firewall for 5 minutes.

**Command Syntax utils firewall enable** [*time*]

enable Turns on the IPv4 firewall.

#### Command Syntax utils firewall list

This commands displays the current configuration of the IPv4 firewall.

Command Syntax utils firewall status

This command displays the current status of the IPv4 firewall.

#### utils firewall ipv6

These commands perform various actions pertaining to the firewall ipv6.

Command Syntax utils firewall debug [off \\ time]

PARAMETERS:

This command turns IPv6 firewall debugging on or off. If you do not enter a time parameter, this command turns on debugging for 5 minutes.

*off* Turns off the IPv6 firewall debugging. If you do not enter the time parameter, this command disables the firewall for 5 minutes.

time (Optional) Sets the duration for which the firewall debugging is to be enabled in the following formats:

- Minutes: 0-1440m
- Hours: 0-23h
- Hours and minutes: 0-23h 0-60m

#### **Command Syntax**

utils firewall disable [time]

*disable* Turns off the IPv6 firewall. If you do not enter the time parameter, this command disables the firewall for 5 minutes.

#### **Command Syntax utils firewall enable** [*time*]

enable Turns on the IPv6 firewall.

#### Command Syntax utils firewall list

This commands displays the current configuration of the IPv6 firewall.

Command Syntax utils firewall status

This command displays the current status of the IPv6 firewall.

### utils import config

This command takes data from the platformConfig.xml file on the virtual floppy drive and modifies the system to match the configuration file. The system will reboot after the command successfully completes.

#### Command Syntax utils import config

PARAMETERS: None

**REQUIREMENTS:** 

Command privilege level: 1

Allowed during upgrade: Yes

#### USAGE GUIDELINES

To run this command on a VMware deployment that has been cloned (copied) from a template:

- 1. Power on the VM.
- 2. Use the Answer File Generator (AFG) tool. For more information, see https://www.cisco.com/c/en/us/applicat/content/cuc-afg/index.html.

- **3.** Insert the Config.xml file into a virtual floppy instance. For more information, see https://kb.vmware.com/s/article/1739.
- 4. Mount the .flp file in the floppy drive of the new VM.

[interval] indicates the interval in seconds. Mandatory if iterations is also used.

[iterations] indicates the number of iostat iterations to be performed. Mandatory if interval is also used.

[filename] redirects the output to a file.

### utils iothrottle

These commands enable, disable, or show status of I/O throttling enhancements.

Command Syntax utils iothrottle disable utils iothrottle enable utils iothrottle status

### utils netdump

This command enables, disable and displays status of the netdump.

Command Syntax utils netdump enable

Command Syntax utils netdump disable

Command Syntax utils netdump status

#### utils netdump client

These commands configure the netdump client.

**Command Syntax utils netdump start** *ip-address-of-netdump-server* This command starts the netdump client.

PARAMETER *ip-address-of-netdump-server* specifies the IP address of the netdump server to which the client will send diagnostic information.

**Command Syntax utils netdump status** This command starts the netdump client.

**Command Syntax utils netdump status** This command displays the status of the netdump client.

### utils network

#### utils network arp

This command lists, sets, or deletes Address Resolution Protocol (ARP) table entries.

**Command Syntax utils network arp delete** *host* This command deletes an entry in the address resolution table.

host represents the host name or IP address of the host to delete from the table.

#### **Command Syntax**

**utils network arp list** [*options*] This command lists the contents of the address resolution protocol table.

**OPTIONS:** 

[host host] is the host and host name to list.

[page] displays the output one page at a time.

[numeric] displays hosts as dotted IP addresses.

#### **Command Syntax**

**utils network arp set** *<host> <address>* This command sets an entry in the address resolution protocol table.

*<host>* is the name or dotted IP address of the host to add to the table.

*<address>* is the hardware address (MAC) of the host to be added.

#### utils network capture

This command captures IP packets on the ethernet interface.

#### **Command Syntax**

utils network capture [options]

**OPTIONS:** 

[page] pauses output.

[numeric] show hosts as dotted IP addresses.

[file fname] outputs the information to a file saved in platform/cli/fname.cap.

[count num] indicates a count of the number of packets to capture.

[size bytes] indicates a count of the number of packets to capture. Note: The maximum count for the screen is 1000; for a file it is 100000.

[src addr] indicates the source address of the packet as a host name or IPV4 address.

[dest addr] indicate the destination address of the packet as a host name or IPV4 address.

[port num] indicates the port number of the packet (either src or dest).

[host protocol] indicates the host address of the packet as a host name or IPV4 address. This option will display all packets to and from that address. Note: If "host" is provided, do not provide "src" or "dest".

#### utils network connectivity

This command is valid only on a subscriber (Member) node. It tests the network connectivity from this system to the publisher node (the Controller node).

#### Command Syntax utils network connectivity

#### utils network host

This command resolves a hostname to an address, or an address to a hostname. This command looks for the host locally first. If it cannot resolve it locally, and DNS is configured, then it does a DNS lookup.

### Command Syntax

utils network host name

PARAMETER name is the name of the host or address to resolve.

#### utils network ping

This command sends one or more ping packets to a remote destination.

Command Syntax utils network ping dest [count] PARAMETER dest is the dotted IP or host name of the destination. OPTION [count] is the optional count value (default is 4).

#### utils network tracert

This command traces IP packets to a remote destination.

Command Syntax utils network tracert *dest* 

PARAMETER dest is the dotted IP or host name of the destination.

#### utils network ipv6

#### Command Syntax

utils network ipv6 host {host\_name \ ipv6\_address}

This command does an IPv6 host lookup (or IPv6 address lookup) for the specified host name or IPv6 address.

*host\_name* Specifies the name of the server.

ipv6\_address Specifies the IPv6 address of the server.

#### Command Syntax

utils network ipv6 traceroute { *ipv6-address* \ *address*}

This command does an IPv6 host lookup (or IPv6 address lookup) for the specified host name or IPv6 address.

hostname Specifies the host name that you want to trace.

ipv6-address Specifies IPv6 address that you want to trace.

#### Command Syntax

utils network ipv6 ping destination [count]

This command allows you to ping an IPv6 address or hostname.

destination Specifies a valid IPv6 address or host name that you want to ping. .

count Specifies the number of times to ping the external server. The default count equals 4.

### utils ntp

This command displays the NTP status or configuration.

Command Syntax utils ntp status utils ntp config

Command Syntax utils ntp restart

#### **Command Syntax utils ntp server add***s1 [ s1| s2| s3| s4| s5 ] [norestart]*

The command adds a maximum of five specified NTP servers.

PARAMETERS:

s1... Specifies the NTP servers.

norestart Causes the NTP service to not restart after you add the servers.

#### Command Syntax utils ntp server delete

This command deletes NTP servers that are configured.



Note The following warning message, changing this setting will invalidate the software licence is not applicable to Cisco Unified Intelligence Center and can be ignored.

#### Command Syntax utils ntp server list

This command lists all NTP servers.

#### Command Syntax utils ntp start

This command starts the NTP service if it is not already running.



Note

You can not stop the NTP service from the command line interface. Use this command when the utils ntp status command returns stopped.

### utils raid disk maintenance

A remote account generates a pass phrase that allows Cisco Systems support personnel to get access to the system for the specified life of the account. You can have only one remote account that is enabled at a time.

account is the account name.

*life* indicates the life of the account in days.

utils remote\_account disable utils remote\_account enable utils remote\_account status

### utils\_reset

These commands reset user names and passwords.

Use this command to reset the application user name. The application user is the initial Super User who can sign in to the Administration console.

This command prompts for the new name.

Make sure to do the following while running this command:

- 1. Run this command only when replication is running.
- 2. Wait for 10 to 15 minutes to ensure that the user name is reset across all nodes.
- 3. Restart the Cisco Unified Intelligence Center application on all nodes to complete the process.



Warning

If you log in to the Cisco Unified Intelligence Center application without completing these steps you will lose all administrator privileges.

This command starts a service.

Command Syntax utils service start serv

PARAMETER serv is the name of the service to start.

### utils service stop

This command stops a service.

Command Syntax utils service stop serv

PARAMETER serv is the name of the service to stop.

### utils snmp

#### utils snmp get

This command gets the SNMP data for the specified MIB OID.

Command Syntax utils snmp get <version> PARAMETERS: version is 1 or 2c. Enter the community string:<Community string> Enter the ip address of the Server :<IP address of the server> *The Object ID (OID)* <Object ID> *Enter parameter as "file" to log the output to a file. [nofile]* < name of the text file> Press Enter to display the results on screen without saving any text files.

#### utils snmp test

This snmp test sends sample alarms to local syslog, remote syslog and snmp trap.

Command Syntax utils snmp test

#### utils snmp walk

This command is used to walk the SNMP MIB starting with the specified OID.

Command Syntax utils snmp walk <version>

PARAMETERS:

version is 1 or 2c.

*Enter the community string:* <Community string>

### utils snmp configure

#### utils snmp config 1/2c community-string

This interactive command adds, deletes, lists or updates a community string.

utils snmp config 1/2c community-string {add | delete | list | update}

PARAMETERS:

add Adds a new community string.

delete Deletes a community string.

list Lists all community strings.

update Updates a community string.

#### utils snmp config 1/2c inform

This interactive command adds, deletes, lists or updates inform notification destinations.

utils snmp config 1/2c inform {add | delete | list | update}

PARAMETERS:

add Adds a notification destination.

delete Deletes a notification destination.

Lists Lists all notification destination.

Update Updates all notification destination.

#### utils snmp config 1/2c trap

This interactive command affects trap notifications.

utils snmp config 1/2c trap {add | delete | list | update}

PARAMETERS:

add Adds a new v1/2c trap notification destination associated with a configured v1/2c community string.

delete Deletes the configuration information for an existing v1/2c trap notification destination.

List Lists the v1/2c trap notifications currently configured.

update Updates configuration information for an existing v1/2c trap notification destination.

#### utils snmp config 3 inform

This interactive command affects the v3 inform notification.

utils snmp config 3 inform {add | delete | list | update}

#### PARAMETERS:

add Adds a new v3 inform notification destination associated with a configured v3 username.

delete Deletes the configuration information for an existing v3 inform notification destination.

list Lists the v3 inform notifications currently configured.

update Updates configuration information for an existing v3 inform notification destination.

#### utils snmp config mib2

This interactive command affects the Mib2 configuration information.

utils snmp config mib2 {add | delete | list | update}

PARAMETERS:

add Adds the Mib2 configuration information.

delete Deletes the Mib2 configuration information.

list Lists the Mib2 configuration information.

update Updates the Mib2 configuration information.

#### utils snmp config 3 trap

This interactive command affects trap notifications.

utils snmp config 3 trap {add | delete | list | update} PARAMETERS: add Adds a new v3 trap notification destination associated with a configured v3 username.

delete Deletes the configuration information for an existing v 3 trap notification destination.

list Lists the v3 trap notifications currently configured.

update Updates configuration information for an existing v3 trap notification destination.

#### utils snmp config 3 user

This interactive command affects v3 user configuration.

utils snmp config 3 user {add | delete | list | update}

PARAMETERS:

add Adds a new v3 user with the v3 authentication and privacy passwords.

delete Deletes the configuration information for an existing v3 user.

list Lists the v3 users currently configured.

update Updates configuration information for an existing v3 user.

### utils soap realtimeservice test

This soap test runs a number of test cases on the remote server as specified by a parameter of remote-ip, remote-https-user, or remote-https-password.

#### **Command Syntax**

utils soap realtimeservice test <remote-ip> <remote-https-user> <remote-https-password>
PARAMETERS: (At least one parameter is required.)
remote-ip = remote ip address of the machine under test
remote-https-user= remote http user who has role to access soap api

### utils system

These commands perform system operations.

#### utils system restart

This command restarts the server after presenting a confirmation (yes | no) message.

Command Syntax utils system restart

#### utils system shutdown

This command shuts the server down after presenting a confirmation (yes | no) message.



**Note** It is important to shut down using this CLI command. Do not shut down by pressing the power button on the server.

These commands show certificate information about the selected certificate type.

**Command Syntax show cert list** *type* PARAMETER *type* is mandatory and can be *own* or *trust*. **show cert own***name* 

show cert ownnume

show cert trustname

PARAMETER name must be a valid certificate name.

### show cli

Run this command to show if pagination of the current CLI session is on or off.

Command Syntax show cli pagination

Run this command to show the CLI session timeout. The CLI session timeout is set to 30 minutes for new CLI sessions.

Command Syntax show cli session timeout

### show cuic-properties

These commands show information about Unified Intelligence Center properties.

### Command Syntax show cuic properties allow-external-links

This command shows the value *on* or *off*, depending on the current value set for the allow-external-links property.

#### **Command Syntax**

This command shows the value *on* or *off*, depending on the current value set for the dashboard-customwidget-enabled property. This value can be set using **set cuic properties dashboard-customwidget-enabled**.

#### Command Syntax

This command shows the current host-to-ip translation for Unified Intelligence Center databases in the cluster.

#### **Command Syntax**

**show cuic properties http-cache** This command shows the value *on* or *off*, depending on the current value that is set for the http-cache property.

This command shows the number of large schedules set for the Unified Intelligence Center web application.

# show hardware

This command retrieves some basic platform hardware information.

# show ipsec

Use these commands to display ipsec policies.

Command Syntax show ipsec information [policy\_group] [policy-name] Use to display detailed information about the specified ipsec policy.

**Command Syntax show ipsec policy\_group** Use to display the list of ipsec policy names with specified policy group.

**Command Syntax show ipsec policy\_name** Use to view a policy with a given policy name and group. Example:set ipsec policy name group1 name1.

**Command Syntax show ipsec status** Use to display the status of all ipsec tunnels defined in the system.

# show logins

This command shows the last number of platform admin logins. The default is to show 20 logins.

### **Command Syntax**

OPTION:

[last n] specifies a number of logins to show. Entering the command with no option shows 20 logins. Specifying a value of 0 will display all previously saved logins.

# show memory

These commands displays information about the server memory.

This command shows information about the current account: machine name, account name, admin privilege level, output setting and logging setting. Use the commands set commandcount and set logging to modify current account settings.

This command retrieves ip\_conntrack\_max information.

# Command Syntax show network all

This command displays security option configured on /etc/ntp.conf file.

This command retrieves some basic platform network route information.

### show open files

These commands show open files.

**Command Syntax show open files all** This command displays all the open files on the machine.

**show open files process** *ProcessID1, ProcessID2* This command displays all the open files on the machine belonging to given process(es).

PARAMETER Processid must be a valid process id. You can enter a comma-delimited list of processes.

#### **Command Syntax**

**show open files regex** "*regex*" This command displays all the open files on the machine that match the regular expression. PARAMETER "regex" is the regular expression to match and must be enclosed in quotation marks.

### show open ports

These two commands show open ports.

**Command Syntax show open ports all** This command shows all open ports.

#### **Command Syntax**

**show open ports regex** *"string"* This command shows all the open ports on the machine that match the regular expression. It takes the parameter *"string"*.

# show packages

These commands retrieve the version number of one or more packages on the active or inactive side.

PARAMETER *pkg* must be a valid package name.

# show password

Use these commands to configure password rules.

This command displays the number of passwords that will be maintained in the history.

### show perf counterhelp

This command lists the explaining text for a particular perfmon counter.

Most Unified Intelligence Center counters display with this command. For example *show perf query class SchedulerInfo* shows the *SchedulerIntervalLength*, *SchedulerJobsCompletedCount*, *SchedulerJobsFailedCount*, *SchedulerJobsRunningCount*, and *SchedulerState*.

*instance-name* is the instance name to view. You can query a maximum of five comma-delimited instance-names. If the name contains white space, enclose it in double quotes.

path-spec is the perfmon query path to view. You can query a maximum of five, comma-delimited path-specs.

## show process

These commands show process information.

### show process list

This command is used to get the list of all the processes, and critical information about each one of them. This command also displays visually the child-parent relationship between these processes.

### show process load

This command shows the current load on the system including the number "num" of processes using the most cpu or memory or time.

Command Syntax show process load [options] OPTIONS: [cont] - the command will repeat continuously.

[clear] - the screen will clear before displaying output.

[noidle] - the command will ignore the idle/zombie processes.

[num XX] - configure the number of processes to be displayed (using most cpu) XX is the number of processes: default is 10 processes; minimum value is 1; use 'all' for all processes.

[thread] - show threads.

[cpu]- sort output by CPU usage.

[memory] - sort output by memory.

[usage time] - sort output by time usage.



**Note** Only one of cpu, memory or time may be specified.

[page] - pause output.

### show process name

This command is used get the details of processes that share the same name. This also displays parent-child relationship.

Command Syntax

show process name process-name [file-filename]

PARAMETER process-name must be a valid process name.

OPTION [file file-name] is the file-name for the output.

### show process open-fd

This command is used to list the open file descriptors for a comma separated list of process Ids.

Command Syntax

show process open-fd p1, p2, p3 [file]

PARAMETER *p1* is the process ID. You can enter a comma-separated string of process IDs.

OPTION [file] is the file-name for the output.

### show process search

This command lets you search some particular patterns in the output of the operating system specific process listing.

Command Syntax show process search regexp [file]

PARAMETER regexp specifies the regular expression.

OPTION [file] is the file-name for the output.

### show process user

This command displays the user and more details on the process used, including the virtual memory used and others.

Command Syntax

show process user user-name [options]

user-name is mandatory.

**OPTION**:

[file] is the file-name for the output.

[vm] is the virtual memory of the process.

[detail] show process's page fault, virtual memory, start time and others.

[cont] to repeat the command continuously.

### show process using-most

These commands show the processes using the most cpu or the most memory.

Command Syntax show process using-most cpu [options] show process using-most memory [options] OPTIONS: [file] - the file-name for the output. [number] - The number of processes. The default is 5.

# show registry

This command displays the contents of the registry.

Command Syntax

show registry <system> <component name> page

PARAMETERS:

system represents the registry system name.

component represents the registry component name.

OPTION: [page] displays one page at a time.

# show smtp

This command shows the SMTP server.

Command Syntax show smtp

# show stats io

This command shows system input/output statistics of the machine.

**Command Syntax show stats io** [options]

**OPTIONS:** 

[kilo] display statistics in kilobytes.

[detail] displays detailed statistics of every available device on the system. This option overrides the [kilo] option.

[page] pauses the output.

[file fname] outputs to a file. The file is saved in platform/cli/fname.txt. The fname must not contain the " character.

# show status

This command retrieves basic platform status.

# show tech

### show tech activesql

This command shows the active queries to the database taken in the last one minute.

Command Syntax show tech activesql

## show tech all

This command displays all of the different show tech xxx commands and may produce a large output of data.

**Command Syntax show tech all** [options]

OPTIONS:

[page] displays one line at a time.

[file fname] outputs to a file saved in platform/cli/fname.txt.

### show cuic tech

These commands display information about the Unified Intelligence Center database.

Command Syntax show cuic tech procedures

This command shows the procedures in use for the Unified Intelligence Center database.

# Command Syntax show cuic tech systables

This command displays the name of all tables in the Unified Intelligence Center database.

**Command Syntax show cuic tech table** *<tablename>* 

This command shows the contents of a table on the Unified Intelligence Center database.

### show cuic tech procedures

This command displays the stored procedures in use for the database.

### **Command Syntax**

#### set cert regen unit name

This command regenerates the certificate for the unit name and prompts for a restart to activate the regenerated certificate.

#### PARAMETERS:

unit and unit name specifies the name of the unit.

# set cli

Run this command to set the pagination of the current CLI session.

### **Command Syntax**

### PARAMETER on or off

Run this command to set the CLI session timeout minutes. Minutes are mandatory. The number of minutes after which sessions are declared to be invalid; range is 5 to 99999.

Command Syntax set cli session timeout minutes

# set commandcount

If enabled, the contents from external links are rendered within the HTML iFrame in the dashboard. This will include the frame-src\* directive in the Content Security Policy of the Unified Intelligence Center web pages.

This command sets the limit for maximum number of large schedules that you can create. The valid range is 1-6 large schedules. The default value is 1.

You must restart the Unified Intelligence Center Reporting Services for the change to take effect

PARAMETER 1<HH:MM > <AM/PM>

PARAMETER 2 < Interval (in minutes)>

This command sets the time of day when the Unified Intelligence Center database will be purged and the duration (in minutes) after which the purge operation should be rerun. The default purge time is 12:00 AM and the default purge interval is 60 minutes.

For  $\langle HH:MM \rangle$  and  $\langle AM/PM \rangle$  specify the time of the day when you want the purge job to run for the first time.

For *<Interval (in minutes)>*, specify the interval in minutes after which you want the purge job to rerun.

After you run this command with the correct parameters, the system displays a message as follows:

Next purge is scheduled to run after <x> hours <y> minutes. Value has been successfully set.

Following are the various categories of data that the system purges when you use these CLI commands:

- 1. Cached report data Data in this category is purged based on the time specified using the set cuic properties purge-time command. Note that the purge time is calculated based on the time when the filter used to run the report was last used or refreshed.
- 2. Audit trail All audit trail data that is older than a month are purged during the last purge operation of the day.
- 3. Cached scheduled report data The set cuic properties purge-retention CLI command applies only to this category.

Each rerun that the system performs using this command, results in the purging of the cached report data. Other categories are purged only during the last purge run of the day.

If you restart the Unified Intelligence Center server after the purge start time, the system discontinues the current purge cycle until the same purge start time on the next day.

For example, if you have set to run the purge job at 11.45 AM on a day with a rerun interval of 1 hour and the Unified Intelligence Center server was restarted at 2 PM, the following happens with respect to the purge runs and reruns:

- Purge job runs typically at 11.45 AM, 12.45 PM., and 1.45 PM.
- After the restart at 2 PM, the system checks for the purge start time and since the purge start time is set as 11.45 AM, the next purge run happens only at 11.45 AM on the next day.

To have continuous rerun even after the system restarts, you must set the purge start time and interval again using the set cuic properties purge-time CLI command.

**Command Syntax** 

set cuic properties purge-retention

#### PARAMETER #number of days

This command sets the number of days that data in the Unified Intelligence Center database is retained before it gets purged. The default is one day and the maximum permissible value is 31 days.



Note Cached scheduled report data - The set cuic properties purge-retention CLI command applies only to this category.

This command configures the cluster publisher hostname and causes a temporary loss of network connectivity while the network is restarted with the new configuration.

#### **Command Syntax**

#### set network cluster publisher ip

This command configures the cluster publisher ip address and causes a temporary loss of network connectivity while the network is restarted with the new configuration.

### set network dhcp eth0

These commands set the ethernet interface to disable dhcp (if enabled) or to use dhcp (if not already enabled). Entering this command prompts for verification and, if run, causes the system to restart.

Command Syntax set network dhcp eth0 enable set network dhcp eth0 disable

### set network dns options

This command allows you to set the dns options.

Command Syntax set network dns options [options]

**OPTIONS:** 

[timeout xx] sets the DNS request timeout in seconds.

[attempts xx] sets the number of times to attempt a DNS request before quitting.

[rotate] causes the system to rotate among the configured DNS servers, distributing the load.

### set network dns {primary | secondary}

These commands set the IP address for the primary or secondary DNS server. Entering this command prompts for verification and, if run, causes a loss of network connectivity.

Command Syntax set network dns primary addr set network dns secondary addr

PARAMETER addr specifies the address of the server.

### set network domain

This command sets the domain name for the system. Entering this command prompts for verification and, if run, causes a loss of network connectivity.

### Command Syntax

set network domain name

PARAMETER name specifies the name of the domain.

### set network failover

These commands enable and disable Network Fault Tolerance on the Media Convergence Server network interface card. Entering the command prompts for verification and, if run, causes the system to restart.

**Command Syntax** set network failover ena op set network failover dis op

PARAMETER op indicates the operation.

### set network gateway

This command enables you to configure the IP address of the network gateway. Entering this command prompts for verification and, if run, causes the system to restart.

Command Syntax set network gateway addr

PARAMETER addr specifies the address of the gateway.

### set network hostname

This command sets the network hostname and then causes a restart of the system The hostname must follow the rules for ARPANET host names. The hostname must start with an alphabet, end with an alphanumeric, and may contain any alphanumeric characters or hyphens in between. The hostname must be 63 characters or less.

Command Syntax set network hostname [name] addr

PARAMETER name specifies the network hostname.

## set network IP eth0

This command sets the IP address for Ethernet interface 0.

The system asks whether you want to continue to run this command. If you continue, this command causes the system to restart.

#### **Command Syntax**

**set network ip eth0** <*ipaddr*> <*mask*> <*gateway*>

PARAMETERS:

ipaddr is the IP address.

mask is the mask.

gateway is the gateway.

### set network ipv6

These commands are used for configuring the IPv6 feature on the machine.

**Command Syntax set network ip dhcp** *action reboot* This command is used for enabling or disabling the DHCPv6 client.

### **Command Syntax**

**set network ip service** *action reboot reboot* This command is used for enabling or disabling the IPv6 feature client.

#### **Command Syntax**

**set network ipv6 static\_address** *addr mask* This command is used for setting the static IPv6 address on the server.

PARAMETERS:

Action is mandatory can have either of these values: {enable | disable}

mask is the mask.

Reboot. Reboot after making these changes.

addr is the IP address.

*mask* is the mask.

### set network max\_ip\_conntrack

This command sets the maximum value for ip\_conntract\_max.

Command Syntax set network max\_ip\_conntrack ip\_conntrack\_max PARAMETER ip conntrack max indicates the maximum value.

### set network mtu

This command sets the maximum MTU value. The valid range is 500-1500.

Command Syntax set network mtu size

PARAMETER size must be 1500 for all servers in the cluster.

## set network nic eth0

This command sets the properties of the Ethernet Interface 0. It asks if you want to continue. If you continue, this command causes a temporary loss of network connections while the NIC is reset.

#### **Command Syntax**

set network nic etho0 auto [{endis}] speed [{10100}] duplex [{halffull}]

PARAMETERS: At least one is mandatory. Each parameter takes options indicated.

auto specifies whether auto negotiation gets enabled or disabled.

speed specifies the speed of the Ethernet connection: 10 or 100 Mbps.

duplex specifies half-duplex or full-duplex.

### set network pmtud

This command enables or disables Path MTU Discovery.

The system asks whether you want to continue to run this command. If you continue, the system temporarily loses network connectivity.

Command Syntax set network pmtud state {enabledisable}

PARAMETER state {enable | disable}

### set network restore

This command restarts the networking on this host. If confirmed, this command causes a temporary loss of network connectivity.



**Caution** Only use this command when all other CLI 'set network ...' commands have failed to restore network connectivity to an Ethernet port. This command removes all previous Ethernet and Network Fault Tolerance settings. The specified Ethernet port is configured with a minimal static IP address configuration. It is imperative that the original Ethernet port settings be reconfigured AFTER this command using other CLI 'set network ...' commands.

### Command Syntax

set network restore <ethernet port> <ip-address> <network-mask> <gateway>

PARAMETERS:

ethernet-port is the Ethernet port (for example, eth0).

ip-address is the IP address of the host.

network-mask is the network mask.

gateway is the Gateway IP address.

### set network status eth0

This command sets the state of the ethernet interface eth0 to up or down.



**Caution** Only use this command when all other CLI 'set network ...' commands have failed to restore network connectivity to an Ethernet port. This command erases all previous Ethernet and Network Fault Tolerance settings. The specified Ethernet port is configured with a minimal static IP address configuration. It's imperative that the original Ethernet port settings be reconfigured AFTER this command using other CLI 'set network ...' commands.

**Command Syntax** set network status eth0 state {updown}

PARAMETER state {up | down} to set the status up or down is required.

# set password

Use these commands to configure password rules.

#### **Command Syntax**

set password age maximum | days minimum | days set password complexity character minimum-length set password system bootloader encryptHash set password change-at-login enable\disable

Use this commands to enable or disable password complexity rules.

**Command Syntax set password expiry** maximum-age minimum-age **set password history** number **set password inactivity** {enabledisableperiod (days)} Use these commands to enable the operating system password inactivity to the default value of 10 days, to disable password inactivity, or set the number of days.

#### Command Syntax

set password user admin security

These commands allow you to change the system administrator and security passwords.

The system prompts you for the old and new passwords and checks the password for strength.

#### PARAMETERS:

#### character takes {enable | disable}

When enabled, passwords need to meet these guidelines:

- Have at least one lower-case character.
- Have at least one uppercase, one digit and one special character.
- Contain no characters that are adjacent on the keyboard.
- Have not been used as any of the previous ten passwords. The admin user password can be changed only once in 24 hours.
- Cannot have been changed in the past 24 hours.

#### minimum-length

When enabled, modify the value of minimum password length for Unified CM OS accounts. Acceptable values should be equal to or greater than 6. Use this command only after enabling the character complexity of passwords.

*maximum days* - Sets the value of the maximum age for the admin accounts in days. Acceptable values should be equal to or greater than 10 days but less than 3650 days (10 years).

*minimum days* - Sets the minimum password age for the admin accounts in days.

maximum-age - Takes {enable | disable).

Enabling the maximum age sets the value of maximum password age to 3650 days (10 yrs) for CUCM OS admin accounts.

minimum-age - Takes {enable | disable).

number - The number of passwords to maintain in history. Default is 10. Maximum is 20. Enter 0 to disable.

admin - Sets the admin password.

security - Sets the security password.

### set smtp

This command sets the SMTP server hostname.

#### **Command Syntax set smtp** *host*

PARAMETER *host* indicates the hostname for the smtp server.

# set cuic syslog

This command sets the syslog as enabled or disabled.

**Command Syntax set cuic syslog** {*enabledisable*}

# set timezone

This command changes or sets the timezone. You must restart the system after you change the timezone.

Command Syntax set timezone zone

PARAMETER zone indicates the timezone.

Enter the appropriate string or zone index id to uniquely identify the timezone.

To see a list of valid timezones, use the show timezone command.

Be aware that the timezone name is case-sensitive.

#### **Related Topics**

# set tls server cert\_type

Use this command to set the server certificate type to either RSA or ECDSA ciphers for TLS connections. The certificate set to the specified type is then presented for the cipher negotiations on all incoming TLS communications.

#### **Command syntax**

set tls server cert\_type [option]

#### Option

ecdsa—Sets the certificate type to ECDSA.

rsa—Sets the certificate type to RSA.

#### Example

# set tls min-version

This command allows you to set the minimum TLS version in the server or client that can be used for inbound or outbound SSL connections respectively. You must restart the system for the changes to take effect.

Note

- When you upgrade the TLS minimum version from TLSv1.0 to TLSv1.1 or TLSv1.2, reinstall the Cisco Unified Real-Time Monitoring Tool.
  - In a multi-node CUIC deployment, run this CLI command on all the nodes of the cluster starting from the publisher. Restart all the nodes after executing the CLI command.

#### **Command Syntax**

**set tls** [server | client]**min-version**<1.0/1.1/1.2>

# set web-security

This command sets the web security certificate information for the operating system.

### **Command Syntax**

**set web-security** *<orgunit> <orgname> <locality> <state> < country>[hostname]* 

PARAMETERS: (First five parameters are mandatory.)

orgunit is the organizational unit.

orgname is the organizational name.

*locality* is the location of the organization.

state is the state of the organization.

country is the country of the organization.

hostname is the alternate hostname. This parameter is optional.

For more information about setting the alternative host name, see https://supportforums.cisco.com/docs/DOC-6119.

# set workingdir

These commands set the CLI working directory for activelog or inactivelog.

Command Syntax set workingdir activelog *directory* set workingdir inactivelog *directory* 

PARAMETER *directory* must be a valid sub-directory of the activelog or inactivelog.

# **Run Commands**

# run loadxml

This command can be run on the publisher (the Controller node) as a workaround when service parameters or product specific information does not appear on the administration screen.

Running this command might necessitate a restart of some services.

Command Syntax run loadxml

# run cuic sql

This runs a SQL command to query and select from the database and table.

**Command Syntax run cuic sql** sql statement [options]

PARAMETER sql statement specifies the SQL command to run. For example, select \* from tablename.

OPTIONS:

[ccm] - operating system database. This is the default. If you do not include the *cuic* option, this command runs a sql statement from the system database.

[cuic] - Unified Intelligence Center database. For example, select \* from cuic:tablename

You can run only one sql\_statement at a time. But in the sql\_statement you can use multiple tables. For example: Select \* from cuic:cuicreport, cuic\_data:cuicreportdefinition.

# run loadcsv

This command runs on the publisher, to install product csv's on the server. It is necessary to run this command on the publisher only.

Running this command might necessitate a restart of some services.

Command Syntax run loadcsv

# file commands



File commands that include **activelog** list a **livedata** directory. For Packaged CCE deployments only, this directory contains logs for the Live Data reporting components.

# file check

This command checks whether any files or directories have been added, removed, or changed in size since the last fresh installation or upgrade. The results display after the check.



Note

This command is system-intensive. Run it at off-hours.

### Command Syntax

**file check** [detection-size-kb]

OPTION: [detection-size-kb] specifies the minimum file size change that is required for the command to display the file as changed. The default is 100Kb.

# file delete

These commands delete one or more specified files.

**Command Syntax file delete activelog** *file-spec* [options] **file delete inactivelog** *file-spec* [options] **file delete install** *file-spec* [options]

PARAMETERS:

*file-spec* specifies the path and filename of the file(s) to delete.

**OPTIONS:** 

[detail] displays a listing of deleted files with the date and time.

[noconfirm] deletes files without asking you to confirm each deletion.



Caution You cannot recover a deleted file, except possibly by using the Disaster Recovery System.

# file dump

These commands dump the contents of the indicated files to the screen, one page at a time.

**Command Syntax file dump activelog** *file-spec* [options] **file dump inactivelog** *file-spec* [options] **file dump install** *file-spec* [options] **file dump sftpdetails** *file-spec* [options]

PARAMETER *file-spec* specifies the path and filename of the file(s) to dump.

**OPTIONS:** 

[detail] displays listing with the date and time.

[hex] displays output in hexadecimal.

# file get

These commands get (transfer) the specified file to another system by using SFTP. After the command identifies the specified files, you are prompted to enter an SFTP host, username, and password.

### **Command Syntax**

file get activelog file-spec [options] file get inactivelog file-spec [options] file get install file-spec [options] file get partBsalog file-spec [options] file get salog file-spec [options]

PARAMETER *file-spec* specifies the path and filename of the file(s) to transfer.

**OPTIONS:** 

[abstime] is absolute time period, specified as hh:mm:MM/DD/YY.

[reltime] is relative time period, specified as minutes | hours | days | weeks | months value.

[match] matches a particular string in the filename, specified as string value.

[recurs] gets all files, including subdirectories.

# file list

These commands list the log files in an available log directory.

#### **Command Syntax**

file list activelog file-spec [options] file list inactivelog file-spec [options] file list install file-spec [options] file list partBsalog file-spec [options] file list salog file-spec [options]

PARAMETER *file-spec* specifies the path to the directory to list.

**OPTIONS:** 

[page] displays the output one screen at a time.

[reverse] reverses sort direction.

[detail] displays a long listing with date and time.[date] sorts by date.[size] sorts by file size.

# file search

These commands search the content of a log and display the matching lines one page at a time.

**Command Syntax file search activelog** *file-spec* [options] **file search inactivelog** *file-spec* [options] **file search install** *file-spec* [options]

### PARAMETERS:

*file-spec* represents the path to the file(s) to search.

reg-exp represents a regular expression.

**OPTIONS:** 

[reltime] only search files that were modified within relative time.

[abstime] only search files that were modified within specific time range.

[ignorecase] ignores case distinctions.

[recurs] searches for the pattern recursively through subdirectories.

# file tail

These commands tail (print the last few lines) of a log file.

#### **Command Syntax**

file tail activelog file-spec [options] file tail inactivelog file-spec [options] file tail install file-spec [options]

PARAMETER *file-spec* specifies the path to the file to tail.

**OPTIONS:** 

[detail] displays a long listing with date and time.

[hex] displays hexadecimal listing.

[lines] specifies number of lines to display.

# file view

These commands display the contents of the logging files specified.

### **Command Syntax file view activelog** *file-spec* **file view inactivelog** *file-spec*

file view install *file-spec* file view system-management-log

PARAMETER *file-spec* specifies the path to the file to view.

# **Delete Commands**

# delete account

This command allows you to delete an administrator account.

Command Syntax delete account *name* PARAMETER *name* specifies the name of the admin account.

# delete dns

This command deletes the specified DNS server from the system and results in loss of network connectivity.

#### **Command Syntax delete dns** *addr*

PARAMETER *addr* specifies the IP address name of the domain name server.

# delete ipsec

These commands allow you to delete IPSec policies. You can delete a pokcy with a given policy name and group.

**Command Syntax delete ipsec policy\_group** [{*groupall*}] Use to delete all policies within a group or to delete all groups.

### **Command Syntax**

delete ipsec policy\_name [policy\_group] [policy\_name]
Use to delete a policy with a given policy name and group. Example: delete ipsec policy\_name group1
name1

PARAMETERS:

policy\_group

policy\_name

# delete process

This command allows you to delete a particular process.

#### **Command Syntax**

delete process *pid* [{options}]

PARAMETER pid specifies the process ID number.

**OPTIONS:** 

[force] stops the process.

[terminate] terminates the process.

[crash] crashes the process with a crash dump.

# delete smtp

This command deletes the SMTP host.

Command Syntax delete smtp

# Load Balance

In cases where a Unified Intelligence Center multi-node deployment experiences a heavy reporting workload, system administrators have the option to deploy server load balancing (SLB).



#### Note

SSO access to the Unified Contact Center Enterprise web applications through the load balancer is not qualified.

SLB is a technique to distribute client requests among the nodes in a cluster or to select the server that can successfully fulfill a client request in the shortest time without overloading that server or the cluster as a whole.



**Note** In a Unified Intelligence Center deployment with SLB, if one of Unified Intelligence Center is down, the report viewer pointing to that server displays this error **Report execution Failed. Please check browser console logs for more info**. When you refresh your browser, a new Unified Intelligence Center log in page will display.



Note

Load balancing for Live Data reports in Unified Intelligence Center is not supported in any deployments.
