About Smart Licensing



Note

Cisco Expressway X14.2 **only** supports Smart Licensing and is capped at 2500 encrypted signaling sessions to endpoints. It also includes changes in the trafficserver behavior (bug ID CSCwc69661 refers) that can lead to MRA failures - see here. For detailed information, see the *Cisco Expressway and Cisco TelePresence Video Communication Server Release Note* (x14.2) and *Cisco Expressway Administrator Guide* (X14.2) before upgrading to X14.2.

Cisco Smart Software Licensing is a new way to think about licensing. From X14.2 release, Smart Licensing is typically managed with the cloud-based Cisco Smart Software Manager (CSSM). Alternatively, deployments that need an on premises approach can use the Smart Software Manager On-Prem product (formerly known as "Smart Software Manager satellite"). Basically it is a cloud-based, software license management solution. It simplifies the licensing experience across the enterprise and makes it easier to purchase, deploy, enables you to automate time-consuming, manual licensing tasks. The solution allows you to easily track the status of your license and software usage trends. It provides visibility into license ownership and consumption through a single, simple user interface.



You place an order on Cisco Commerce and the order is associated with the smart account, this information is populated on Smart Software Manager, which resides on cisco.com. Now you have a complete view on what you have ordered and purchased.

You can use Smart Licensing to:

- See the license usage and count.
- See the status of each license type.
- See the product licenses available on Cisco Smart Software Manager or Smart Software Manager On-Prem.
- Renew License Authorization with Cisco Smart Software Manager or Smart Software Manager On-Prem.
- Renew Registration
- Deregister with Cisco Smart Software Manager or Smart Software Manager On-Prem.
- Reregister License with Cisco Smart Software Manager

mportant	• Product Activation Keys (PAK) Licensing (Option Keys) are removed from version X14.2.
	• Smart License is default and the only licensing mode for Expressway-C and Expressway-E.
	• We recommend you to enable Smart License before upgrading Expressway to version X14.2. This will help while reverting to a previous image.
	• You are not allowed to add the Microsoft Interoperability (MS Interop) key from version X14.2. This functionality is available only in cases where you have the MS Interop options before upgrade. But onc on X14.2, you cannot add MS Interop key.
	 Once Smart Licensing is turned ON, you do not have an option for reverting to Cisco VCS through Service Select.
	• Once Smart Licensing is turned ON, you cannot disable it and revert to legacy licensing. There is no option available to revert it to Cisco VCS (except for a Factory Reset), either.
	• For Cisco VCS, legacy/option key license mode remains the only licensing mode.

This cons	product has Smart Licensing <i>enabled</i> (through CLI and GUI), is registered to CSSM, and reports license umption to CSSM. Two models exist to report the usage:
	Direct Model- Use this model in networks where devices can communicate directly to the Internet or can connect to the Internet via a HTTPS proxy. Communication to Cisco.com is through HTTPS, therefore all traffic is encrypted during transport. If the traffic is sent through a HTTPS proxy, all communications between devices and Cisco.com are channeled through a centralized location if additional inspection or security policies have to be applied.
•	Mediated Deployment Model- Use this model in networks where devices cannot connect to the Internet and therefore cannot reach Cisco.com. This deployment model requires installing a CSSM satellite virtual machine on your premises which all internal hosts can reach. The on-premise satellite can be deployed in a connected mode that synchronizes with CSSM. The synchronization with cisco.com can be either monthly, weekly, or can be deployed in a totally disconnected configuration requiring manual file uploads

Factory Reset

The following are a few changes to the way Factory Reset works for Expressway Devices.

- Cisco VCS Factory Reset is unchanged.
- Flag Removed: Flag `-o` (saving of the option keys) is removed from the Expressway factory reset.

• To reset the unit to factory default settings, at the command prompt, execute the following command.



Note Use the chosen flags (if you have any) when you perform a factory reset or you will be prompted with the following list if you do not give any flags in the command.

- New Flags Added: Two new flags `-v` (device brand and type) and `-t` (Smart License configuration settings) are added.
 - '-v' flag: When the factory reset is triggered and the `-v` flag is chosen, the device prompts you to save the brand and box type of their device (where brand is Expressway Series or Cisco VCS and type is Expressway-E or Expressway-C).

Condition:

Choice is "No": The default values are Expressway-C and Cisco VCS.

 '-t' flag: When the factory reset is triggered and the `-t` flag is chosen, the device prompts you to save the Smart Licensing configuration.

Conditions:

- Choice is "No": The Smart Licensing is reverted to '*Direct*' if the device is still an Expressway.
- Choice is "Yes": The Smart Licensing configuration and registration (if it exists) is preserved.

In this case, after factory reset the device will go offline until the DNS settings are configured. This means, you will see two different alarms indicating the Smart License registration and authentication are not working. These alarms will clear when the device goes back online.

For more information on alarms (Alarm IDs - 30042 and 30044), see Alarms Reference.

- The new factory reset is FIPS compliant.
- At the command prompt, execute the following command:

```
# factory-reset --help - Lists all the available options.
```

Restrictions for Smart Licensing

You are not allowed to add the Microsoft Interoperability (MS Interop) Option Key from version X14.2. This functionality is available only in cases where you have the MS Interop Option Key before upgrade from Cisco VCS to Expressway Series. But once on X14.2, you cannot add MS Interop Option Key.



Note

After Factory Reset, if the MS Interop option key is on the device, it will be preserved.

How Smart Licensing Works

Cisco Smart Software Licensing (Smart Licensing) is a new approach to licensing which is enabled across multiple Cisco products. It simplifies licensing and makes license ownership and consumption clearer. Devices self-register and report license consumption, which removes the need to use option keys (Product Activation Keys). License entitlements are pooled in a single account that can be used across Expressways or across different clusters of Expressways. You can use a license on any compatible device owned by your company and move them around to meet the needs of your organization.

You use Smart Licensing to register/deregister Expressway with the Cisco Smart Software Manager (CSSM) or the Cisco Smart Software Manager On-Prem to view/monitor smart license usage, count/manage licenses, know the status per license type, and renew license authorizations. CSSM is hosted on the Cisco Software Manager and allows product instances to register and report license consumption to it.

There are two main deployment options for Smart Licensing:

- Cisco Smart Software Manager
- Cisco Smart Software Manager On-premises

Cisco Smart Software Manager

The Cisco Smart Software Manager is a cloud-based service that handles your system licensing. It enables you to manage all of your Cisco Smart software licenses from one centralized website. With Cisco Smart Software Manager, you can organize and view your licenses in groups called virtual accounts (collections of licenses and product instances). The Cisco Smart Software Manager allows you to:

- · Create, manage, track, or view virtual accounts
- · Create and manage Product Instance Registration Tokens
- Transfer licenses across virtual account or view licenses
- · Transfer, remove, or view product instances
- · Remove registered product instance
- Run reports against your virtual accounts
- · View overall account information

On-premises option - using Smart Software Manager On-Prem

If you do not want to manage Cisco products directly using Cisco Smart Software Manager, either for policy or network availability reasons, you can instead use Smart Software Manager On-Prem. This is an on-premises component of Cisco Smart Licensing and products register and report license consumption to it in the same way as with Cisco Smart Software Manager.

Smart Software Manager On-Prem can be deployed in either Connected or Disconnected mode, depending on whether the satellite can connect directly to cisco.com.

- Connected. Used when there is direct connectivity to cisco.com. Smart account synchronization occurs automatically.
- Disconnected. Used when there is no direct connectivity to cisco.com. Smart Account synchronization
 must be manually uploaded and downloaded.

Creating a Smart Account

Smart Account provides the repository for Smart enabled products and enables you to manage Cisco Licenses. Once they are deposited, you can activate licenses, monitor license usage and track them. You can manage your Smart Account directly. A Smart Account is needed to fully utilize the license management features of the smart enabled products. The creation of Smart Account is a one-time setup activity.

Requesting License Reservation for Your Smart Account

Complete the following steps to request license reservation to your Smart Account in Cisco Smart Software Manager:

- 1. Go to Support Case Manager.
- 2. Click OPEN NEW CASE.
- 3. Select Software Licensing.

The licensing team will contact you to start the process or for any additional information.

Before You Enable Smart Licensing

This section has some caveats to be aware of before you implement Smart Licensing on Expressway.

Caution After Smart Licensing is enabled, the only way to revert to PAK-based licensing (or to convert an Expressway system to a Cisco VCS system) is with a factory reset. Because a factory reset reinstalls the software image and resets the Expressway configuration to the default, we strongly advise you to backup the Expressway data before you enable Smart Licensing.

Product Instance Evaluation Mode

After enabling Smart Licensing on Expressway allows only a 90-day Evaluation period. During the evaluation period, Expressway does allow cluster-related configuration. After the evaluation period, if Expressway is not registered with either CSSM or Smart Software Manager On-Prem, the product moves to Unauthorized state. In the Unauthorized state, it does not allow new device registrations until the product is registered.

After Smart Licensing is enabled, you cannot use option keys on the Expressway. So, if you want to use any Expressway functions that still require option keys, use PAK-based licensing.

We recommend you to set up Smart and Virtual accounts before you review the general Expressway licensing information in Call Types and Licensing. For details, see Cisco Smart Accounts.

Smart Licensing Settings

This section describes how to use the Smart Licensing settings in the Expressway web interface to do the following:

- Enable Smart Licensing.
- Register and deregister the Expressway with CSSM or Smart Software Manager On-Prem.
- Manually renew the registration and license authorization.
- View system license usage information as it is reported to CSSM or Smart Software Manager On-Prem. (Licenses are assigned to your organization's Smart Account and are not locked to a device.)

This section describes the web interface. For information about CLI commands for Smart Licensing, see the *Command Reference* section of this guide.

Field	Description Enables Smart Licensing on this Expressway product instance. Before you select this option, review the Smart Licensing Settings section.

	Note It is always recommended to take a configuration backup in order to avoid any partial or complete configuration lost scenario.

Configure Smart Licensing

This section describes the tasks required to configure Smart Licensing.

Before You Start

Review the cautions and other information in Before You Enable Smart Licensing.

The following additional configuration caveats apply:

- The only supported transport protocol is HTTPS between Expressway and CSSM / Smart Software Manager On-Prem.
- If a communication issue occurs with the registration server when you register the Expressway product instance, the registration fails with this message: *The last attempt to renew smart software licensing registration is in progress because of the following reason: HTTP Server Error 200: Operation timed out.*

The product instance reattempts to register at 15-minute intervals. Refresh the page on your browser after each reattempt, to check current registration status. If the communication issue is resolved during the reattempts, the product will be registered. If the product is not registered after multiple reattempts, verify if there is any communication issue with the registration server and manually reregister the product instance.

- When you restore a system, the Smart Licensing settings that are restored depends on whether you restore the backup onto the same system or on a different system.
 - If you restore on the same system, the registration settings are restored on the restored system.
 - If you restore on a different system, you must register the product again with a registration key.
- If you are configuring Smart Software Manager On-Prem, be sure to enter the exact URL of the Smart Transport component (details and an example are provided in Smart Licensing Settings).

Process Summary

- 1. Obtain the Product Instance Registration Token
- 2. Configure Transport Settings on Expressway
- 3. Register with Cisco Smart Software Manager

Obtain the Product Instance Registration Token

This task gets the product instance registration token from CSSM or Smart Software Manager On-Prem to register the product instance. Tokens can be generated with or without Export-Controlled functionality. Detailed information is available from Cisco Software Central.

- Step 1 Log in to your smart account in CSSM or Smart Software Manager On-Prem.
- **Step 2** Navigate to the virtual account that you want to associate with the Expressway.
- **Step 3** Generate a Product Instance Registration Token.
- **Step 4** Select the **Allow export-controlled functionality on the products registered with this token** check box to enable export-controlled functionality on the products registered with this token.

Caution Use this option only if you are compliant with the export-controlled functionality.

By checking this check box and accepting the terms, you enable higher levels of product encryption for products registered with this Registration Token. By default, this check box is selected. You can uncheck this check box to disallow Export-Controlled functionality on a product.

The **Allow export-controlled functionality on the products registered with this token** check box is not displayed for Smart Accounts that are not permitted to use the Export-Controlled functionality.

Step 5 Copy the token or save it to another location.

Configure Transport Settings on Expressway

This task selects the transport settings for Expressway to communicate to CSSM.

- **Step 1** In the Expressway web interface, go to **Maintenance** > **Smart licensing**.
- **Step 2** Navigate to **Transport settings** and select one of the following transport options:
 - *Direct* Expressway sends usage information directly over the internet and no additional components are needed. This is the default.
 - Smart Software Manager On-Prem Expressway sends usage information to an on-premise CSSM.
 - Proxy Server Expressway sends usage information over the internet through a proxy server.

Details about the transport settings are provided in Smart Licensing Settings. Remember that if the Expressway product instance is already registered, you must first deregister it if you want to change transport settings from Direct (CSSM) to On-Prem, or the other way round.

- **Step 3** If the hostname and IP address of this product instance must not be exchanged with CSSM or Cisco Smart Software Manager On-Prem, check the setting **Do not share my hostname or IP address with Cisco**.
- Step 4 Click Save.

Register with Cisco Smart Software Manager

This task registers your Expressway with CSSM or Smart Software Manager On-Prem. Until you register, the product runs in Evaluation Mode. You need the Product Instance Registration Token (see Obtain the Product Instance Registration Token) and transport settings must be configured as described in the previous task.

- **Step 1** In the Expressway web interface, go to **Maintenance** > **Smart licensing**.
- **Step 2** In the **Registration** section, paste the Product Instance Registration Token that you previously generated using CSSM or Smart Software Manager On-Prem.
- **Step 3** Click **Register** to complete the registration process. (After successful registration the button changes to **Reregister**.)
- **Step 4** In the License usage section, click Update usage details to manually update the system license usage information. This is resource-intensive and may take a few minutes depending on the size of the system.

The configuration for Smart Licensing is now complete.

The following section describes how to manage Smart Licensing registrations and authorizations, including what to do if the Expressway hostname is changed in future, or if you decide to permanently shut it down.

Important Configuration Information for Smart Licensing

Caution After Smart Licensing is set to On you cannot reset to Off using the web interface. To go back to PAK-based licensing (or to change the system to a VCS) requires a factory reset. For detailed information on <u>Factory Reset</u>, see the chapter Smart Licensing, section Factory Reset in Cisco Expressway Administrator Guide (X14.2). Because the reset will reinstall the software image and reset the Expressway configuration to the default, we strongly advise you to backup the Expressway data before you enable Smart Licensing.

- After Smart Licensing is enabled, you cannot use option keys on the Expressway.
- If a communication issue occurs with the registration server when you register the Expressway product instance, the registration fails with this message:

Manage Smart Licensing Registrations and Authorizations

This section describes Smart Licensing operations, including:

• *Renew Authorization*: Use to manually renew the License authorization status for all the licenses listed under the License type. The license authorization is renewed automatically every 30 days. The authorization status will expire after 90 days if it is not connected to CSSM or Smart Software Manager On-Prem.

- *Renew Registration*: Use to renew the registration information manually. The initial registration is valid for one year. Renewal of registration is automatically done every six months provided the product is connected to CSSM or Smart Software Manager On-Prem.
- *Deregister*: Use to disconnect the Expressway from CSSM or Smart Software Manager On-Prem. The product reverts to evaluation mode as long as the evaluation period is not expired. All license entitlements used for the product are immediately released back to the virtual account and are available for other product instances to use it.
- *Reregister License with Cisco Smart Software Manager*: Use to reregister Expressway with CSSM or Smart Software Manager On-Prem. The product may migrate to a different virtual account by reregistering with a token from a new virtual account.

Important Caveat

Smart Licensing Registration is a per-node operation. This means that a cluster of two or more peers requires every peer to register with Smart Licensing.

Renew Authorization

Use this procedure to manually renew the License authorization status for all the licenses listed under the **License type**. This process assumes that the product is registered with CSSM or Smart Software Manager On-Prem.

- **Step 1** In the Expressway web interface, go to **Maintenance** > **Smart licensing**.
- Step 2 In the Action section, from the Additional operations drop-down list, choose *Renew authorization now*.
- Step 3 Click Save.

Expressway sends a request to Cisco Smart Software Manager or Smart Software Manager On-Prem to check the "License Authorization Status" and Cisco Smart Software Manager or Smart Software Manager On-Prem reports back the status to Cisco Expressway.

Step 4 In the **License usage** section, click **Update usage details** to manually update the system license usage information. This is resource-intensive and may take a few minutes depending on the size of the system.

Renew Registration

During product registration to Cisco Smart Software Manager or Smart Software Manager On-Prem, a security association is used to identify the product and is anchored by the registration certificate, which has a lifetime of one year (the registration period). This is different from the registration token ID expiration, which has the time limit for the token to be active. This registration period is automatically renewed every 6 months. However, if there is an issue, you can manually renew this registration period.

This process assumes that the product is registered with CSSM or Smart Software Manager On-Prem.

- **Step 1** In the Expressway web interface, go to **Maintenance** > **Smart licensing**.
- **Step 2** In the Action section, from the Additional operations drop-down list, choose *Renew registration now*.

Step 3 Click Save.

Expressway sends a request to CSSM or Smart Software Manager On-Prem to check the "Registration Status" and CSSM / Smart Software Manager On-Prem reports the status to Cisco Unified Communications Manager.

Deregister

Use this procedure to unregister an Expressway from CSSM or Smart Software Manager On-Prem and release all the licenses from the current virtual account. This procedure also disconnects the Expressway from CSSM / Smart Software Manager On-Prem. All license entitlements used for the product are released back to the virtual account and are available for other product instances to use.

If Expressway is unable to connect with CSSM or Smart Software Manager On-Prem, and the product is still deregistered, a warning message displays. The message notifies you to remove the product manually from CSSM / Smart Software Manager On-Prem to free up licenses.

- **Step 1** In the Expressway web interface, go to **Maintenance** > **Smart licensing**.
- **Step 2** In the Action section, from the Additional operations drop-down list, choose Deregister.
- Step 3 Click Save.
- **Step 4** In the License usage section, click Update usage details to manually update the system license usage information. This is resource-intensive and may take a few minutes depending on the size of the system.

Reregister with Cisco Smart Software Manager

Use this procedure to reregister the Expressway with CSSM or Smart Software Manager On-Prem. You need the Product Instance Registration Token (see Manage Smart Licensing Registrations and Authorizations).

- Step 1From the web interface, choose Maintenance > Smart licensing.
The Smart licensing window appears.
- **Step 2** In the **Registration** section, paste the "Registration Token Key" that you generated using the CSSM or Smart Software Manager On-Prem.
- **Step 3** Click **Reregister** to complete the reregistration process.
- **Step 4** In the **License usage** section, click **Update usage details** to manually update the system license usage information. This is resource-intensive and may take a few minutes depending on the size of the system.

How to Register a Change to the Expressway Hostname

If the Expressway hostname is changed, to reflect the change in CSSM, go to the **Expressway Smart Licensing** web page and click "Renew Registration Now".

Step 4 In the License usage section, click Update usage details to manually update the system license usage information. This is resource-intensive and may take a few minutes depending on the size of the system.

Deregister First if Expressway is Permanently Shutdown

We recommend that if you plan to shutdown an Expressway machine permanently, you first deregister the product instance from the Expressway Smart Licensing web page. This is to avoid leaving unused product instances in CSSM.

In case you forget to do so, there is an alternate approach to remove the Expressway product instance from the CSSM portal.

This step is not needed for restarts or temporary shutdowns.

About Cisco Smart License Reservation and Its Types

Cisco Smart License Reservation is meant to reserve licenses and install them on the device. This process enables you to generate a unique reservation code from your Cisco device, which is then used to reserve a license type and quantity from your Cisco Smart Account's inventory.

The following are the license reservation types:

- Permanent License Reservation (PLR): All licenses are reserved.
- Specific License Reservation (SLR): Only specific licenses are reserved.



Note The following processes are common for both Permanent License Reservation (PLR) and Specific License Reservation (SLR).

Reserving a New Smart License

Section Purpose: This section outlines the procedure to reserve a new smart license for use.

The user can specify and reserve licenses against the product. For more information, see Requesting License Reservation for Your Smart Account. After the authorization code is exchanged, regular product synchronization is not required until there are changes in the reservation. Reserved licenses remain blocked in the Cisco Smart Software Manager unless released from the product with a return code.

Figure 1: Reserve Licenses



Updating a Smart License Reservation

Use the Cisco Smart Software Manager to update or change reserved licenses (increase or decrease). You can install a new authorization code on the Product and obtain a confirmation code. The new changes remain in transit status unless confirmation code from the product is installed on the Cisco Smart Software Manager.





Removing the Product Instance from CSSM

You can remove the product from the smart account and release all the licenses that are reserved for that Product Instance (Expressway) when licenses are reserved on a Product Instance (Expressway).

Product Instance is operational (graceful removal): Users can create a Reservation Return Code on the Product Instance (which removes the Authorization Code) using the Cisco Smart Software Manager and return the Specific License Reservation Authorization.



Figure 3: Remove a Product Instance - Expressway

Note

User can use only the CLI configuration to enable Permanent License Reservation and Specific License Reservation.

Functionality

Customers entitled to License reservation feature on their Smart Account can reserve licenses from their virtual account, tie them to a devices Unique Device Identifier (UDI) and use their device with these reserved licenses in a disconnected mode. The customer reserves specific licenses and counts the UDI from their virtual account.

CLI Commands for PLR and SLR

The table lists a set of CLI commands applicable for PLR and SLR.

Prerequisites

- Enable smart licensing before executing the reservation commands.
- Select the appropriate PLR or SLR licenses using the CLI commands before running the smart licensing commands.

Permanent License Reservation

Permanent License Reservation (PLR) is a part of Cisco smart licensing solution. Smart Licensing needs a smart account. The product must connect to the Cisco Smart Software Management (CSSM) or Smart Software Manage (SSM On-Prem) in order to reactivate and report the most recent license status. You will use Cisco Permanent License Reservation or PLR license if you have extremely secured inner networks with restricted internet access.

You can apply Permanent licenses over evaluation licenses, and also apply it incrementally (that is, you can have multiple permanent licenses, and so on). Its capabilities are designed for highly secure environments, where communication with outside environment is impossible.

How does PLR Licenses Work?

Permanent License Reservation is a permanent solution for highly secure network architecture where all outbound connections are limited. PLR license allows you to register all product instances along with unlimited features (along with all entitlements on Expressway till the physical capacity of the Expressway box) and permanently (no renewal needed) using a reservation code. This solution is similar to traditional PAK licenses and is mostly available for Cisco Secure product lines. Furthermore, PLR licenses counts as an easy-to-use and intuitive solution which can be applied easily on different devices. In addition, you can provide a single authorization code to permanently enable all features or eliminate various features and expiration dates.

How to Apply PLR Licenses?

There are a few Command Line Interface (CLI) commands. These commands can generate a reservation code. You can use the reservation code to receive a unique authorization code. Entering this Authorization Code in CLI will permanently activate all features.

Task Flow

You can use a set of commands through the Command Line Interface (CLI) to call the Smart Agent and obtain the required information. You can paste this information on the Cisco Smart Software Manager (CSSM) portal.

This reservation is also called Online-Offline mode. You must be online to register and use the reservation. First, deregister yourself if you have already registered to enable reservation and start the process.

Complete these tasks to reserve permanent licenses for Expressway.

Enable Reservation

Note Reservation is disabled by default. You must enable it.

Sharing of Licenses Across Nodes in a Cluster

Consider Node 1 and Node 2 where,

Node 1: 10 Desk Registrations + 10 Rich Media Session (RMS)

Node 2 : 10 Desk Registrations + 10 RMS

Explanation: 10 RMS licenses are consumed when there are 10 Business to Business (B2B) calls made from Node 1.

A cluster license is shared among all the nodes. For example, Node 1 has 10 licenses, if 11th endpoint tries to register then the Node automatically borrows 1 license from other nodes.

Information: The license is borrowed only if there are no available RMS licenses in Node 1.



Note This behavior is similar to PAK-based licenses.

Reporting of the License Consumption to Smart Agent

The license consumption is reported to the Smart Agent over pre-configured intervals.

Within a cluster if 1 node consumes more than the installed licenses then only the number of installed licenses will be reported.

For example, In a 2 node cluster, if each node has 10 licenses then 1 node can consume a maximum of 20 licenses. In that case, it will be reporting only the installed number of licenses that is, 10 licenses instead of 20 licenses.

Limitation





Make sure that Smart Licensing is *enabled* and Expressway is in *Specific License Reservation (SLR)* mode.

Hard Enforce Entitlement for SLR/Expiry of Smart License Reservation Licenses

After the license expires, there is no impact on the registration of calling functionalities of the Expressway device until it is restarted.

After the Expressway device is restarted, if the license has expired, the respective functionality will stop and an alarm is triggered.

The functionality associated with license expiry does stop immediately since the device triggers a notification only upon restart.

Smart Licensing Export Compliance

Note

- The Export Limit of 2500 registrations/calls/sessions is *On* by default for all customers. This means that now every customer will **not** be able to create more than 2500 encrypted connections.
 - · Advanced Account Security is not available.
 - From X14.2, FIPS140-2 Cryptographic Mode is available.

FIPS140-2 mode is **only available** on Cisoc Video Communication Server (VCS) with the *Advanced Security option key* and *Expressway Select*, **not** *Expressway* (Export Control Restricted version).

• Encrypted signaling sessions to endpoints' is capped at 2500.

Export Control Alarms

The Export Control approaching alarm and approached alarm are raised once calls and registration capacity have reached 90% and 100% of the export control limit, respectively.

Export Control limit is ideally set to a count of 2500 (Calls+Registrations). This applies to both Smart Licensing *Connected* and *Reservation* mode(s).

For more information, see "Alarms Reference".

Additional Information

The following are the values used for Export Control.

Lower Watermark for Export Control

In Export Control, a lower watermark is introduced to update if the export control limit is reached or not. The lower watermark is a 1% value of the current export control limit (~2500).

This is to avoid call(s) to change notification when there is a frequent change in the resource usage value.

For example, if the export control limit is reached (\sim 2500). Consequently, a few calls and registrations are dropped. In the current scenario, it is considered that the export limit is reached only when calls or registrations drop until 25 (1% of 2500). New Registrations or Calls are allowed only when the resource usage value is below 2475. This is to avoid call(s) to change notification between 100% to 99% range.

Export Control Limit When WebRTC is Enabled

When WebRTC is enabled on either Cisco Expressway-C or Cisco Expressway-E, the Export Control limit value is set to 2244, since the maximum WebRTC connections allowed on the Expressway C or E is 256.

When the WebRTC value is disabled, the Export Control limit is set back to 2500.

Restore Process in Smart Licensing Model

You can backup settings on one Expressway and restore it to a different Expressway. For example, You can use this feature when the original system has failed. Before restoring, install the option keys assigned in the original system to the new system.

If you are using the Smart Licensing model, re-apply the token (in case there are multiple users) or assign a new token before restoring the backup file.

VCS Behavior

The 2500 Limit is applicable to VCS also. But the requirement to go over the limit with crypto key is not available. From X14.2, VCS always will be within the limit and there is no crypto key to go above the 2500 limit.

Limitations

Product License Registration - Issue with Converting to Smart Licensing

This item applies if you want to convert existing Expressway licenses (RMS, Desktop, or Room) to Smart Licensing entitlements. In this case do not use the option in the Cisco Product License Registration portal to partially convert just some of the licenses. Due to a known issue, if you opt to convert only some licenses, the system automatically forfeits/removes the remaining licenses as well. So the licenses that are not converted are also removed, and a licensing case will be required to retrieve them.

To avoid this happening, please ensure that the **Quantity to Convert** field is the same value as the **Quantity Available** field; this is the default when you open the page.

Smart Licensing not Available With Features that Use Option Keys (including HSM)

The following Expressway features are enabled by option keys. Because option keys are incompatible with Smart Licensing, if you need these features, you must use PAK-based licensing and not Smart Licensing:

- Advanced account security
- HSM (Hardware Security Module)
- Microsoft Interoperability

Expressway Reporting "Unknown CA" for Smart Licensing Through Proxy Server with Intercept Mode

The Expressway does not initiate connections with a proxy or a smart licensing server. A smart licensing agent component initiates these connections. The smart licensing agent validates certificates using its *trust store* list. Users cannot change this list. Therefore, the device rejects connections to any proxy server presenting a CA signed certificate other than the "QuoVadis Root CA 2" with an "Unknown CA" error.
