## Cisco and BT make IP-based communications available to smaller businesses

Joint BT and Cisco initiatives, previewed at the "VoIP for Business" show, help SMEs migrate from legacy PBX systems to fully converged IP-based services

In the future our VoDSL capabilities will enable business IP Communications services to be delivered over a DSL line."
