Section 1: Gaining Access to Cisco Service Contract Center

Note: If you do not have a Cisco.com user ID, you will be unable to access Cisco Service Contract Center. Having had access to Service Contract Center (SCC) does not mean that you have automatic access to Cisco Service Contract Center.

4. Log in to Cisco Service Contract Center.	 a. To access the Cisco Service Contract Center solution, you must first log in to the <u>Cisco Service Contract Center front page</u> on Cisco.com. Click the front page link above and use your Cisco.com user ID and password to gain access. When you click the link, you will see the Customer Log In Site. b. From the Log In Site, Under "Existing User" enter your Cisco.com ID and password. c. Click Login to access the Cisco Service Contract Center front page. d. From the front page, click the Log In button under Access, Support and Training to enter the Cisco Service Contract Center application. e. Enter your Cisco.com ID and password. f. If you are able to successfully log in to Cisco Service Contract Center, then go to Section 2 for information about how to access your contracts. g. If you are not able to login successfully, you will be automatically directed to a page titled, "Having trouble logging in?" At the bottom of this page is a link that you can use to Log a Support Case with the Service Support Center (SSC). 	e.	Click Save Preferences.	
	f.	Log out of Cisco Service Contract Center when you are prompted.	
 Set your default service level preferences. 	a.	Log back in to Cisco Service Contract Center after completing Step 5f in Section 2. 	b.	From the Dashboard, navigate to the top, right corner of the screen and click Preferences .	
	c.	When the Preferences pop-up window appears, choose the Estimates/Quotes tab.	
	d.	Click Service Level & Co-Term.

7. Run the Online Contract Management Assignment Report to see what contracts you have access to in Cisco Service Contract Center.	 From inside Cisco Service Contract Center follow these steps: a. Mouse over the General tab, and click the Reports menu. b. Under Step 1: Choose User Contract Registration Report from the drop- down list. c. Under Step 2: Specify Report Options, choose the email report format and ensure that the correct email ID is listed in the Send Email to field. d. Click the Run Report button. e. You will receive the report in your email inbox shortly after clicking Run Report. Please inform the agent about your business relationship with Cisco. Specifically, the agent needs to know that you are a Service Provider who purchases services directly from Cisco. This information will help the agent to obtain the approvals that are required to grant you access to your contract c. Go to Step 10 to review important information that you should request when you open your Case with the Service Support Center. 11. Request association to specific contracts.	 a. Mouse over the Administration tab and click Register Contracts. b. Enter the contract numbers of the contracts that you need access to (maximum 300 at one time) and click the Register button. c. You will see a list at the top of the screen in red text telling you which contracts were successfully added and which failed. Note: This process automatically grants access to contracts (without opening a support case). It takes about 15 to 20 minutes to propagate the system and then 24 to 48 hours to appear in Partner Opportunity Manager. 	Refer to the <u>web-based training</u> for details on getting access and registering contracts.
